- 5 SECTION 1. Subchapter B, Chapter 822, Health and Safety
- 6 Code, is amended by amending the subchapter and by transferring
- 7 Section 822.033 to the subchapter, renumbering that section as
- 8 Section 822.013, and amending that section to read as follows:
- 9 SUBCHAPTER B. DOGS AND COYOTES THAT ARE A DANGER TO ANIMALS
- Sec. 822.011. DEFINITIONS. In this subchapter:
- 11 (1) "Dog or coyote" includes a crossbreed between a
- 12 dog and a coyote.
- 13 (2) "Livestock" includes exotic livestock as defined
- 14 by Section 161.001, Agriculture Code.
- 15 Sec. 822.012. CERTAIN DOGS AND COYOTES PROHIBITED FROM
- 16 RUNNING AT LARGE; CRIMINAL PENALTY. (a) The owner, keeper, or
- 17 person in control of a dog or coyote that the owner, keeper, or
- 18 person knows is accustomed to run, worry, or kill <u>livestock</u>,
- 19 domestic animals, or fowls [goats, sheep, or poultry] may not
- 20 permit the dog or coyote to run at large.
- 21 (b) A person who violates this section commits an offense.
- 22 An offense under this subsection is punishable by a fine of not more
- 23 than \$100.
- (c) Each time a dog or coyote runs at large in violation of

- 1 this section constitutes a separate offense.
- 2 Sec. 822.013 [822.033]. DOGS OR COYOTES THAT ATTACK
- 3 [DOMESTIC] ANIMALS. (a) A dog or coyote that is attacking, is
- 4 about to attack, or has recently attacked livestock, [sheep, goats,
- 5 calves, or other] domestic animals, or fowls may be killed by:
- 6 (1) any person witnessing the attack; or
- 7 (2) the attacked animal's owner or a person acting on
- 8 <u>behalf of the owner if the owner or person has</u> [having] knowledge of
- 9 the attack.
- 10 (b) A person who kills a dog or coyote as provided by this
- section is not liable for damages to the owner, keeper, or person in
- 12 <u>control</u> of the dog <u>or coyote</u>.
- 13 (c) A person who discovers on the person's property a dog or
- 14 <u>coyote</u> known or suspected of having killed <u>livestock</u>, [sheep,
- 15 goats, calves, or other] domestic animals, or fowls [is a public
- 16 nuisance. Any person] may detain or impound the dog or coyote and
- 17 return it to its [until the dog's] owner or deliver the dog or
- 18 coyote to the local animal control authority. The owner of the dog
- or coyote is liable for all costs incurred in the capture and care
- 20 of the dog or coyote [is notified] and all damage done by the dog or
- 21 <u>coyote</u> [has been determined and paid to the proper persons].
- 22 (d) The owner, keeper, or person in control of a dog or
- 23 <u>coyote</u> that is known to have attacked <u>livestock</u>, [sheep, goats,
- 24 calves, or other] domestic animals, or fowls shall control the dog
- or coyote in a manner approved by the local animal control authority
- 26 [kill the dog. A sheriff, deputy sheriff, constable, police
- 27 officer, magistrate, or county commissioner may enter the premises

- 1 of the owner of the dog and kill the dog if the owner fails to do
- 2 so].
- 3 (e) A person is not required to acquire a hunting license
- 4 under Section 42.002, Parks and Wildlife Code, to kill a dog or
- 5 coyote under this section.
- 6 SECTION 2. Sections 822.032 and 822.034, Health and Safety
- 7 Code, are repealed.
- 8 SECTION 3. The change in law made by this Act to Section
- 9 822.011, Health and Safety Code, applies only to an offense
- 10 committed on or after the effective date of this Act. An offense
- 11 committed before the effective date of this Act is covered by the
- 12 law in effect when the offense was committed, and the former law is
- 13 continued in effect for that purpose. For purposes of this section,
- 14 an offense was committed before the effective date of this Act if
- 15 any element of the offense occurred before that date.
- SECTION 4. This Act takes effect September 1, 2003.
