- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 802, Government Code, is 6 amended by adding Section 802.1024 to read as follows:
- Sec. 802.1024. CORRECTION OF ERRORS. (a) Except as

  provided by Subsection (b), if an error in the records of a public

  retirement system results in a person receiving more or less money

  than the person is entitled to receive under this subtitle, the

  governing body of the retirement system shall correct the error and

  so far as practicable adjust any future payments so that the

  actuarial equivalent of the benefit to which the person is entitled
- is paid. If no future payments are due, the governing body of the
- 15 retirement system may recover the overpayment in any manner that
- 16 would be permitted for the collection of any other debt.
- 17 <u>(b) Except as provided by Subsection (c), a public</u> 18 retirement system:
- 19 <u>(1) may correct the overpayment of benefits to a</u>
  20 person entitled to receive payments from the system by the method
- 21 <u>described by Subsection (a) only for an overpayment made during the</u>
- 22 three years preceding the date the governing body of the system
- 23 discovers or discovered the overpayment; and
- 24 (2) may not recover from the recipient any overpayment

- 13 the fund for an overpayment or incorrect payment of benefits to the
- 14 retiree or beneficiary.
- 15 SECTION 5. This Act applies to an underpayment or
- overpayment of benefits by a public retirement system made by the
- 17 governing body of the system regardless of whether the underpayment
- 18 or overpayment was made before the effective date of this Act,
- 19 except that it does not apply to an overpayment that has been
- 20 resolved by agreement made before the effective date of this Act
- 21 between the governing body of a public retirement system and the
- 22 recipient of the overpayment.
- 23 SECTION 6. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect September 1, 2003.
