- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 302, Occupations Code, is
- 6 amended by adding Section 302.0001 to read as follows:
- 7 Sec. 302.0001. SHORT TITLE. This chapter may be cited as
- 8 <u>the Licensed Vocational Nursing Practice Act.</u>

- 9 SECTION 2. Section 302.003, Occupations Code, is amended to 10 read as follows:
- Sec. 302.003. APPLICATION OF CHAPTER. (a) This chapter does not apply to:
- 13 (1) <u>gratuitous</u> nursing <u>care</u> of the sick <u>that is</u>
  14 provided [<del>without charge</del>] by a friend;
- 15 (2) nursing care provided by a registered nurse 16 licensed under Chapter 301;
- 17 (3) nursing care provided during a disaster under the
- 18 state emergency management plan adopted under Section 418.042,
- 19 Government Code, if the person providing the care does not
- 20 represent that the person is a licensed vocational nurse, unless
- 21 <u>the person is licensed in another state;</u>
- 22 (4) nursing care in which treatment is provided solely
- 23 by prayer or spiritual means;
- 24 (5) an unlicensed person acting under the delegated

2	(A) a physician licensed by the Texas State Board
3	of Medical Examiners; or
4	(B) a registered nurse licensed under Chapter 301
5	or authorized to practice in this state under Chapter 304, as added

8	(6) an act performed by a person licensed by another
9	state agency if the act is authorized by the statute under which the
10	person is licensed;
11	(7) the practice of nursing that is incidental to a
12	program of study by a student enrolled in a board-accredited
13	vocational nurse education program leading to an initial license as
14	a licensed vocational nurse; or
15	(8) the practice of nursing by a licensed vocational
16	nurse or licensed practical nurse licensed in another state who is
17	in this state on a nonroutine basis for a period not to exceed 120
18	hours to provide:
19	(A) care to a patient being transported into, out
20	of, or through this state; or
21	(B) vocational nursing.
22	(b) This chapter does not authorize the practice of medicine
23	as defined by Chapter 151. [or family member; or
24	[ <del>(2) a person who does not:</del>
25	[(A) represent to the public that the person is a
26	licensed vocational nurse; or
27	[ <del>(B) use the abbreviation "L.V.N."</del> ]

- 1 SECTION 3. Section 302.056(b), Occupations Code, is amended
- 2 to read as follows:
- 3 (b) A board member may [not] receive reimbursement for
- 4 travel expenses [, including expenses for meals and lodging, other
- 5 than transportation expenses. A member is entitled to
- 6 reimbursement for transportation expenses] as provided by the
- 7 General Appropriations Act.
- 8 SECTION 4. Section 302.151, Occupations Code, is amended by
- 9 amending Subsection (b) and adding Subsection (c) to read as
- 10 follows:
- 11 (b) The board may adopt <u>and enforce</u> rules <u>consistent with</u>
- 12 this chapter and [as] necessary to:
- 13 (1) perform [govern] its duties and conduct
- 14 proceedings before the board;
- 15 (2) regulate the practice of vocational nursing;
- 16 (3) establish standards of professional conduct for
- 17 license holders under this chapter; and
- 18 (4) determine whether an act constitutes the practice
- 19 of vocational nursing [and to implement the purposes of this
- 20 chapter].
- (c) Rules adopted by the board related to the scope of the
- 22 practice of vocational nursing must be consistent with this chapter
- 23 <u>and other law.</u>
- SECTION 5. Subchapter D, Chapter 302, Occupations Code, is
- amended by adding Section 302.159 to read as follows:
- Sec. 302.159. ADVISORY COMMITTEE. (a) The Practice
- 27 Advisory Committee shall advise the board regarding rules related

- 8 appointed under Subdivisions (b)(1), (2), and (13) are not entitled
- 9 to reimbursement for expenses.
- SECTION 6. Subchapter E, Chapter 302, Occupations Code, is
- amended by adding Section 302.207 to read as follows:
- 12 Sec. 302.207. MANDATORY REPORTING REQUIREMENTS. (a) A
- 13 hospital, nursing home, or other employer of a licensed vocational
- 14 nurse shall report to the board the name of each licensed vocational
- 15 nurse whose employment is terminated, or who resigns to avoid
- 16 termination, for engaging in any conduct specified by Section
- 17 302.401 or 302.402.
- 18 (b) A person is not liable in a civil action for a failure to
- 19 report as required by Subsection (a).
- 20 (c) The appropriate state licensing agency may take action
- 21 against a person regulated by the agency for a failure to report as
- 22 <u>required by Subsection (a).</u>
- 23 SECTION 7. Section 302.255(a), Occupations Code, is amended
- 24 to read as follows:
- 25 (a) The director of education or the director of education's
- 26 designee shall visit and survey each vocational nursing institution
- 27 to determine whether the board's minimum requirements for

- 1 vocational nurse education programs are being met.
- 2 SECTION 8. Section 302.256(a), Occupations Code, is amended
- 3 to read as follows:
- 4 (a) The director of education or the director of education's
- 5 designee [board] periodically shall survey each vocational nurse
- 6 education program offered in this state. A written report of the
- 7 survey must be submitted to the board.
- 8 SECTION 9. Section 302.301(a), Occupations Code, is amended
- 9 to read as follows:
- 10 (a) A person may not <u>practice vocational nursing or</u> use the
- 11 designation "Licensed Vocational Nurse" or the abbreviation
- 12 "L.V.N." unless the person holds a license under this chapter.
- SECTION 10. Section 302.307(b), Occupations Code, is
- 14 amended to read as follows:
- 15 (b) A temporary permit expires on the date:
- 16 (1) the applicant receives a permanent license from
- 17 the board; or
- 18 (2) the board notifies the applicant that the
- 19 applicant has failed the examination [a failing examination result
- 20 for the applicant is reported to the board].
- SECTION 11. Sections 302.403 and 302.409, Occupations Code,
- 22 are amended to read as follows:
- Sec. 302.403. DISCIPLINARY AUTHORITY OF BOARD; METHODS OF
- 24 DISCIPLINE. After a hearing is held on specific sworn written
- 25 charges [filed by the secretary-treasurer], if the board determines
- that a person has committed an act listed in Section 302.402, the
- 27 board may:

- 1 (1) refuse to admit the person to a board examination;
- 2 (2) deny the person's application for a license,
- 3 license renewal, or temporary permit;
- 4 (3) issue a warning or reprimand;
- 5 (4) suspend or revoke the person's license as a
- 6 vocational nurse; or
- 7 (5) place on probation a person whose license has been
- 8 suspended.
- 9 Sec. 302.409. APPEAL. A person may appeal a board order
- 10 disciplining the person [in a district court of the county of the
- 11 person's residence].
- 12 SECTION 12. Subchapter I, Chapter 302, Occupations Code, is
- amended by adding Section 302.412 to read as follows:
- 14 Sec. 302.412. CONFIDENTIALITY. (a) A complaint and
- 15 investigation concerning a licensed vocational nurse under this
- subchapter, and all information and material compiled by the board
- in connection with the complaint and investigation, are:
- 18 (1) confidential and not subject to disclosure under
- 19 Chapter 552, Government Code; and
- 20 (2) not subject to disclosure, discovery, subpoena, or
- 21 other means of legal compulsion for release to anyone other than the
- 22 <u>board or a board employee or agent involved in license holder</u>
- 23 <u>discipline.</u>
- 24 (b) Notwithstanding Subsection (a), information regarding a
- 25 complaint and an investigation of a licensed vocational nurse may
- 26 be disclosed to:
- 27 (1) a person involved with the board in a disciplinary

L3	confidential and are subject to disclosure in accordance with
L4	Chapter 552, Government Code.
L5	SECTION 13. Section 302.501, Occupations Code, is amended
L6	to read as follows:
L7	Sec. 302.501. INJUNCTIONS. $\underline{(a)}$ On petition of the board, a
L8	district court may enjoin a person who is violating this chapter
L9	from continuing the violation.
20	(b) A petition under this section may be filed in a district

24	(3) the county in which the violation is occurring.

- 1 Sec. 302.551. SUPERVISION AND DELEGATION. (a) In this
- 2 section, "delegate" means to grant a person the legal authority to
- 3 perform an act the person is not otherwise legally authorized to
- 4 perform.
- 5 (b) A licensed vocational nurse may only practice under the
- 6 supervision of a registered nurse, physician, dentist, podiatrist,
- 7 or other health care provider authorized to order the
- 8 administration of medications and treatments.
- 9 <u>(c) A licensed vocational nurse may not delegate a health</u>
- 10 care task, activity, or function to another person.
- 11 Sec. 302.552. PROTECTION FOR REFUSAL TO ENGAGE IN CERTAIN
- 12 CONDUCT. (a) A person may not suspend, terminate, or otherwise
- discipline or discriminate against a licensed vocational nurse who
- 14 refuses to engage in an act or omission relating to patient care
- 15 that would constitute a ground for disciplinary action under
- 16 Section 302.403 if the licensed vocational nurse notifies the
- 17 person at the time of the refusal that the reason for refusing is
- 18 that the act or omission:
- 19 (1) constitutes a ground for disciplinary action by
- 20 the board; or
- 21 (2) is a violation of this chapter or a rule of the
- 22 board.
- 23 (b) An act by a person under Subsection (a) does not
- 24 constitute a violation of this section if a nursing peer review
- 25 committee under Chapter 303 determines:
- 26 (1) that the act or omission the licensed vocational

18	RELYING ON INFORMATION. (a) A person may not be subject to
19	liability for damages in a civil action if the person, in good
20	faith, provides to the board information relating to:
21	(1) an alleged incident of negligence or malpractice
22	on the part of a holder of or an applicant for a license under this
23	<pre>chapter; or</pre>
24	(2) the qualifications, fitness, or character of a
25	holder of or an applicant for a license under this chapter.
26	(b) The board and the staff of the board may not be subject
27	to liability for damages in a civil action for taking action in

- 2 Sec. 302.554. PROTECTION FOR REPORTING CERTAIN
- 3 INFORMATION. A person may not suspend, terminate, or otherwise
- 4 discipline or discriminate against a person who, in good faith,
- 5 provides information to the board as provided by Section
- 6 302.553(a).
- 7 SECTION 15. Section 303.002(b), Occupations Code, is
- 8 amended to read as follows:
- 9 (b) The board shall enter into a memorandum of understanding
- 10 with each state agency that licenses, registers, or certifies a
- 11 facility required by law to have a <u>nursing</u> [<u>registered nurse</u>] peer
- 12 review committee. The memorandum of understanding must:
- 13 (1) state the actions the board and agency are to take

- 4 (c) A [registered] nurse who in good faith requests a peer 5 review determination under Subsection (b):
- 6 (1) may not be disciplined or discriminated against
  7 for making the request;
- 8 (2) may engage in the requested conduct pending the 9 peer review;
- 10 (3) is not subject to the reporting requirement under 11 Subchapter I, Chapter 301; and
- 12 (4) may not be disciplined by the board for engaging in 13 that conduct while the peer review is pending.
- (d) The determinations of the peer review committee shall be considered in a decision to discipline the nurse, but the determinations are not binding if a [registered] nurse administrator believes in good faith that the peer review committee has incorrectly determined a [registered] nurse's duty.
- 19 (f) A [registered] nurse's rights under this section may not 20 be nullified by a contract.
- 21 (h) A person is not required to provide a peer review 22 determination under this section for a request made by:
- (1) a registered nurse unless the person regularly
  employs, hires, or otherwise contracts for the services of at least
  five registered nurses; or
- 26 (2) a licensed vocational nurse unless the person 27 regularly employs, hires, or otherwise contracts for the services

- 2 SECTION 17. Section 531.051(f), Government Code, is amended
- 3 to read as follows:

- 6 which payment is provided under the voucher payment program

- 2 are repealed.
- 3 SECTION 19. (a) This Act takes effect September 1, 2003.
- 4 (b) As soon as practicable on or after the effective date of
- 5 this Act, the Board of Vocational Nurse Examiners shall appoint the
- 6 members of the Practice Advisory Committee established under
- 7 Section 302.159, Occupations Code, as added by this Act.
