A BILL TO BE ENTITLED

1 AN ACT

2 relating to resident tuition for military personnel and their

3 dependents.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Sections 54.058(c), (d), (f), and (g), Education

6 Code, are amended to read as follows:

- 7 (c) $\underline{\text{The}}$ [As long as they reside continuously in Texas, the]
- 8 spouse or child [and children] of a member of the Armed Forces of
- 9 the United States who has been assigned to duty elsewhere
- immediately following assignment to duty in Texas \underline{is} [are] entitled
- 11 to pay the tuition fees and other fees or charges provided for Texas
- 12 residents as long as the spouse or child resides continuously in
- 13 $\underline{\text{Texas}}$.
- 14 (d) A spouse or dependent child of a member of the Armed
- 15 Forces of the United States, who is not assigned to duty in Texas
- 16 but who has previously resided in Texas for a six-month period, is
- 17 entitled to pay the tuition fees and other fees or charges provided
- 18 for Texas residents for \underline{any} [\underline{a}] term or semester at an institution
- 19 of higher education if the member:
- 20 (1) at least one year preceding the first day of the
- 21 term or semester executed a document with the applicable military
- 22 service that is in effect on the first day of the term or semester
- 23 and that:
- 24 (A) indicates that the member's permanent

- 1 residence address is in Texas; and
- 2 (B) designates Texas as the member's place of
- 3 legal residence for income tax purposes;
- 4 (2) has been registered to vote in Texas for the entire
- 5 year preceding the first day of the term or semester; and
- 6 (3) satisfies at least one of the following
- 7 requirements:
- 8 (A) for the entire year preceding the first day
- 9 of the term or semester has owned real property in Texas and in that
- 10 time has not been delinquent in the payment of any taxes on the
- 11 property;
- 12 (B) has had an automobile registered in Texas for
- 13 the entire year preceding the first day of the term or semester; or
- 14 (C) at least one year preceding the first day of
- 15 the term or semester executed a will that has not been revoked or
- 16 superseded indicating that the member is a resident of this state
- 17 and deposited the will with the county clerk of the county of the
- 18 member's residence under Section 71, Texas Probate Code.
- 19 (f) The spouse or child [and children] of a member of the
- 20 Armed Forces of the United States who dies or is killed is [are]
- 21 entitled to pay the resident tuition fee if the spouse or child
- 22 becomes a resident [wife and children become residents] of Texas
- within 60 days of the date of death.
- 24 (q) If a member of the Armed Forces of the United States is
- 25 stationed outside Texas and the member's [his] spouse or child
- 26 establishes [and children establish] residence in Texas by residing
- 27 in Texas and by filing with the Texas institution of higher

- education at which the spouse or child plans [they plan] to register
- 2 a letter of intent to establish residence in Texas, the institution
- of higher education shall permit the spouse or child [and children]
- 4 to pay the tuition, fees, and other charges provided for Texas
- 5 residents without regard to length of time that the spouse or child
- 6 <u>has</u> [they have] resided in <u>Texas</u> [the state].
- 7 SECTION 2. Section 54.058, Education Code, as amended by
- 8 this Act, applies beginning with tuition charged for the 2003 fall
- 9 semester.
- 10 SECTION 3. This Act takes effect immediately if it receives
- 11 a vote of two-thirds of all the members elected to each house, as
- 12 provided by Section 39, Article III, Texas Constitution. If this
- 13 Act does not receive the vote necessary for immediate effect, this
- 14 Act takes effect September 1, 2003.
