A BILL TO BE ENTITLED 1 AN ACT 2 relating to open-enrollment charter schools. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 12.1054, Education Code, is amended by 4 5 adding Subsection (c) to read as follows: 6 (c) Not later than September 15 of each year, an open-enrollment charter school shall provide to the agency a report 7 that includes the name and a brief biography, including any 8 9 substantial business interests, of each individual serving: (1) on the governing body of the school's charter 10 11 holder; 12 (2) on the governing body of the school; or 13 (3) as an officer of the school. SECTION 2. Section 12.110(b), Education Code, is amended to 14 read as follows: 15 (b) The application form must provide for including the 16 information required under Section 12.111 to be contained in a 17 charter and, in connection with the information required under 18 Section 12.111(12), the application form must provide for 19 specifically describing the manner in which an annual internal and 20 21 external audit of the use of state funds received for the school are to be conducted. The application form also must provide for 22 23 including: 24 (1) a detailed plan concerning the manner in which

1	state funds received for the school are to be spent;
2	(2) the name and business address of the person who is
3	to serve as the school's external auditor;
4	(3) the name and business address of each person who
5	will have responsibility for the school's financial operation; and
6	(4) a description of the system that will be used in
7	making purchases for the school.
8	SECTION 3. Subchapter D, Chapter 12, Education Code, is
9	amended by adding Section 12.131 to read as follows:
10	Sec. 12.131. MAXIMUM SALARY. The agency by rule shall adopt
11	a maximum salary for an officer of an open-enrollment charter
12	school. The maximum salary must be:
13	(1) reasonable; and
14	(2) similar to the salary earned by a person in a
15	similar position in a noncharter public school.
16	SECTION 4. Section 12.110(b), Education Code, as amended by
17	this Act, applies only to an application for an open-enrollment
18	charter school submitted on or after September 1, 2003.
19	SECTION 5. (a) Not later than December 31, 2003, the Texas
20	Education Agency shall establish a maximum salary for officers of
21	open-enrollment charter schools, as required by Section 12.131,
22	Education Code, as added by this Act.
23	(b) Section 12.131, Education Code, as added by this Act,
24	applies only to a salary established under a contract executed on or

25 after January 1, 2004. A salary established under a contract 26 executed before January 1, 2004, is governed by the law in effect on 27 the date the contract was executed, and the former law is continued

in effect for that purpose.
SECTION 6. This Act takes effect September 1, 2003.
