Sections 2(c) and (j), Chapter 88, Acts of the 5 77th Legislature, Regular Session, 2001 (Article 6243h, Vernon's 6 Texas Civil Statutes), are amended to read as follows: 7 The pension board consists of <u>nine</u> [11] trustees as 8 (c) follows: 9 (1) the mayor of the city, or the director of the civil 10 11 service commission as the mayor's representative; 12 (2) the city treasurer or a person performing the 13 duties of treasurer; 14 (3) four municipal employees of the city who are 15 members of the pension system; (4) two retirees, each of whom: 16 (A) has at least five years of credited service 17 18 in the pension system; 19 receives a retirement pension from the (B) pension system; and 20 21 (C) is not an officer or employee of the city; 22 and 23 (5) one person who [three persons, each of whom]: (A) [is a registered voter in the city; 24

H.B. No. 601 1 [(B)] has been a resident of <u>this state</u> [the 2 city] for the three years preceding the date of initial 3 appointment; and

(B) [(C)] is not a city officer or employee.

5 (j) To serve as a trustee under Subsection (c)(5) of this 6 section, the [a] person must be appointed by a vote of a majority of the elected trustees of the pension board [the governing body of the 7 8 city]. The [Each] trustee appointed under Subsection (c)(5) of 9 this section serves a two-year term. The appointment or reappointment of [both] the appointed trustee [trustees] shall take 10 place in January of each even-numbered year. The appointed trustee 11 may be removed at any time by a vote of a majority of the elected 12 trustees of the pension board. A vacancy caused by the [an] 13 appointed trustee's death, resignation, or removal shall be filled 14 15 by the elected trustees of the pension board [governing body of the city]. The appointee serves for the remainder of the unexpired term 16 17 of the replaced trustee. An appointed trustee may not serve beyond the expiration of the two-year term other than by appointment for a 18 new term by the elected trustees of the pension board [governing 19 body of the city]. 20

21 SECTION 2. Section 3, Chapter 88, Acts of the 77th 22 Legislature, Regular Session, 2001 (Article 6243h, Vernon's Texas 23 Civil Statutes), is amended by adding Subsection (n) to read as 24 follows:

(n) Notwithstanding any other law, the pension board may
enter into a written agreement with the city regarding pension
issues and benefits. The agreement must be approved by the pension

board and the governing body and signed by the mayor and by the 1 2 pension board or the pension board's designee. The agreement is enforceable against and binding on the city and the pension 3 4 system's members, retirees, deferred participants, beneficiaries, 5 eligible survivors, and alternate payees. 6 SECTION 3. The heading to Section 15, Chapter 88, Acts of 7 the 77th Legislature, Regular Session, 2001 (Article 6243h, Vernon's Texas Civil Statutes), is amended to read as follows: 8 9 Sec. 15. [ANNUITY] INCREASE IN BENEFITS. SECTION 4. Section 15, Chapter 88, Acts of the 77th 10 Legislature, Regular Session, 2001 (Article 6243h, Vernon's Texas 11 Civil Statutes), is amended by adding Subsection (d) to read as 12 follows: 13 14 (d) A pension benefit or allowance provided by this article 15 may be increased if: 16 (1) a qualified actuary selected by the pension board 17 determines that the increase cannot reasonably be considered to jeopardize the pension system's ability to pay any existing 18 19 benefit; (2) the increase is approved by the pension board and 20 21 the city in a written agreement as provided by Section 3(n) of this article; and 22 (3) the increase does not deprive a member or retiree, 23 24 without the written consent of the member or retiree, from receiving the immediate or deferred retirement benefit that the 25 26 member or retiree was eligible to receive under this article before 27 the increase.

SECTION 5. The terms of the appointed trustees serving 1 under Section 2(c)(5), Chapter 88, Acts of the 77th Legislature, 2 Regular Session, 2001 (Article 6243h, Vernon's Texas Civil 3 4 Statutes), on the effective date of this Act expire on that date. 5 Not later than October 1, 2003, a pension board shall appoint or 6 reappoint a trustee to reflect the changes made by this Act to Section 2, Chapter 88, Acts of the 77th Legislature, Regular 7 8 Session, 2001 (Article 6243h, Vernon's Texas Civil Statutes), for a term expiring in January 2004, as provided by Section 2(j), Chapter 9 88, Acts of the 77th Legislature, Regular Session, 2001 (Article 10 6243h, Vernon's Texas Civil Statutes), as amended by this Act. 11

SECTION 6. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2003.
