4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 142, Local Government Code, is amended
6	by adding Section 142.013 to read as follows:
7	Sec. 142.013. BUSINESS LEAVE TIME ACCOUNT FOR POLICE
8	OFFICERS IN CERTAIN MUNICIPALITIES. (a) This section applies only
9	to police officers employed by a municipality with a population of
10	one million or more that has not adopted Chapter 174 and to which
11	Section 143.1261 does not apply.
12	(b) In this section:
13	(1) "Business leave" means leave taken for the purpose
14	of attending to the business of an employee organization.
15	(2) "Employee organization" includes:
16	(A) the Texas Peace Officers Association;
17	(B) the Dallas Police Association;
18	(C) the Dallas Fraternal Order of Police; and
19	(D) the Latino Peace Officers Association.
20	(c) A police officer may donate not more than two hours for
21	each month of accumulated vacation or compensatory time to the

account for each employee organization.

- 1 (d) The police officer must authorize the donation in 2 writing on a form provided by the employee organization and 3 approved by the municipality. After receiving the signed 4 authorization on an approved form, the municipality shall transfer 5 donated time to the account monthly until the municipality receives 6 the police officer's written revocation of the authorization.
- 7 (e) Only a police officer who is a member of an employee 8 organization may use for business leave purposes the time donated 9 to the account of that employee organization. A police officer may 10 use for business leave purposes the time donated under this section 11 without receiving a reduction in salary and without reimbursing the 12 municipality.
  - (f) A request to use for business leave purposes the time in an employee organization's time account must be in writing and submitted to the municipality by the president or the equivalent officer of the employee organization or by that officer's designee.

- 17 <u>(g) The municipality shall grant a request for business</u>
  18 <u>leave that complies with Subsection (f) unless:</u>
- 19 <u>(1) denial of the request is necessary because of an</u> 20 emergency; or
- 21 (2) a grant of the request will result in having an 22 insufficient number of police officers to carry out the normal 23 functions of the municipality.
- 24 (h) The municipality shall account for the time donated to
  25 the account and used from the account. The municipality shall
  26 credit and debit the account on an hour-for-hour basis regardless
  27 of the cash value of the time donated or used.

- (i) An employee organization may not use for business leave

  purposes more than 4,000 hours from its business leave time account

  under this section in a calendar year. This subsection does not

  prevent an employee organization from accumulating more than 4,000

  hours, but only addresses the total number of donated hours that an

  employee organization may use in any calendar year.
- 7 (j) The use of business leave by a police officer under this 8 section is not a break in service for any purpose and is treated as 9 any other paid leave.
- SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2003.
