5	SECTION 1. Section 411.122, Government Code, is amended by
6	amending Subsections (a) and (c) and adding Subsection (d) to read
7	as follows:
8	(a) Except as provided by Subsection (c)(2), an agency of
9	this state <u>listed in Subsection (d)</u> or a political subdivision of
10	this state covered by Chapter 53, Occupations Code, that licenses

- this state <u>listed in Subsection (d)</u> or a political subdivision of this state covered by Chapter 53, Occupations Code, that licenses or regulates members of a particular trade, occupation, business, vocation, or profession is entitled to obtain from the department criminal history record information maintained by the department that relates to a person who [is]:
- 15 (1) is an applicant for a license from the agency; [or]
- 16 (2) <u>is</u> the holder of a license from the agency; or
- 17 <u>(3) requests a determination of eligibility for a</u>
 18 <u>license from the agency</u>.
- 19 (c) This section does not apply to an agency that is:
- 20 (1) specifically authorized by this subchapter to 21 obtain criminal history record information from the department; or
- (2) covered by Section 53.002, Occupations Code, to the extent provided by that section.
