5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 80, Human Resources Code, is amended by
7	adding Section 80.002 to read as follows:
8	Sec. 80.002. CRIMINAL HISTORY RECORDS SEARCH FOR VOLUNTEERS
9	IN CHILDREN'S ORGANIZED SPORTS; LIABILITY FOR CONDUCT OF
10	VOLUNTEERS. (a) In this section:
11	(1) "Children's organized sports" means any athletic
12	activity:
13	(A) in which persons who are younger than 18
14	years of age are the primary intended participants; and
15	(B) that is sponsored, organized, or supervised
16	by an entity one of whose primary purposes or functions is to
17	sponsor, organize, or supervise athletic, civic, or cultural
18	activities for persons who are younger than 18 years of age.
19	(2) "Criminal history records search" means a search
20	of the criminal convictions database and the sex offender
21	registration database maintained by the Department of Public

Safety.

(3) "Volunteer" means a person who, without

- 1 or supervises children engaged in children's organized sports.
- 2 (b) A person or organization sponsoring, organizing, or
- 3 supervising children's organized sports shall conduct a criminal
- 4 history records search with respect to each person volunteering or
- 5 seeking to volunteer in children's organized sports.
- 6 (c) A person or organization sponsoring children's
- 7 organized sports is liable in a civil action for damages for
- 8 personal injury, death, or property damage that is a result of a
- 9 volunteer's action or omission if the action or omission:
- 10 <u>(1) occurs during a children's organized sports</u>
- 11 activity or in the course and scope of the volunteer's duties; and
- 12 (2) could have been reasonably foreseen as a result of
- a criminal history records search conducted under Subsection (b).
- 14 SECTION 2. Section 84.007, Civil Practice and Remedies
- 15 Code, is amended by adding Subsection (h) to read as follows:
- (h) This chapter does not apply to liability created under
- 17 <u>Section 80.002, Human Resources Code.</u>
- SECTION 3. (a) This Act takes effect September 1, 2003.
- 19 (b) The change in law made by this Act applies only to a
- 20 cause of action that accrues on or after the effective date of this
- 21 Act. A cause of action that accrues before the effective date of
- 22 this Act is governed by the law in effect at the time the action
- 23 accrued, and the former law is preserved for that purpose.
