19 <u>Sec. 254.013. PEACE OFFICERS. (a) The board may commission</u> 20 <u>as a peace officer to enforce this subtitle an employee who has been</u> 21 <u>certified as qualified to be a peace officer by the Commission on</u> 22 <u>Law Enforcement Officer Standards and Education.</u>

23 (b) An employee commissioned as a peace officer under this
24 subtitle has the powers, privileges, and immunities of a peace
25 officer while carrying out duties as a peace officer under this
26 subtitle.

SECTION 3. This Act takes effect immediately if it receives

a vote of two-thirds of all the members elected to each house, as
provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2003.
