A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to postconviction DNA testing.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- SECTION 1. Article 64.01(c), Code of Criminal Procedure, is amended to read as follows:
- 6 (c) A convicted person is entitled to counsel during a
- 7 proceeding under this chapter. The convicting court shall appoint
- 8 <u>counsel for the convicted person if the [If a convicted]</u> person
- 9 informs the [convicting] court that the person wishes to submit a
- 10 motion under this chapter, the court finds reasonable grounds for a
- 11 motion to be filed, and $[\frac{if}{i}]$ the court determines that the person is
- 12 indigent[, the court shall appoint counsel for the person].
- 13 Compensation of counsel is provided in the same manner as is
- 14 required by:
- 15 (1) Article 11.071 for the representation of a
- 16 petitioner convicted of a capital felony; and
- 17 (2) Chapter 26 for the representation in a habeas
- 18 corpus hearing of an indigent defendant convicted of a felony other
- 19 than a capital felony.
- 20 SECTION 2. Article 64.03(a), Code of Criminal Procedure, is
- 21 amended to read as follows:
- 22 (a) A convicting court may order forensic DNA testing under
- 23 this chapter only if:
- 24 (1) the court finds that:

- 1 (A) the evidence:
- 2 (i) still exists and is in a condition
- 3 making DNA testing possible; and
- 4 (ii) has been subjected to a chain of
- 5 custody sufficient to establish that it has not been substituted,
- 6 tampered with, replaced, or altered in any material respect; and
- 7 (B) identity was or is an issue in the case; and
- 8 (2) the convicted person establishes by a
- 9 preponderance of the evidence that:
- 10 (A) [a reasonable probability exists that] the
- 11 person would not have been [prosecuted or] convicted if exculpatory
- 12 results had been obtained through DNA testing; and
- 13 (B) the request for the proposed DNA testing is
- 14 not made to unreasonably delay the execution of sentence or
- 15 administration of justice.
- 16 SECTION 3. Article 64.04, Code of Criminal Procedure, is
- 17 amended to read as follows:
- Art. 64.04. FINDING. After examining the results of
- 19 testing under Article 64.03, the convicting court shall hold a
- 20 hearing and make a finding as to whether the results are favorable
- 21 to the convicted person. For the purposes of this article, results
- 22 are favorable if, had the results been available [before or] during
- the trial of the offense, it is reasonably probable that the person
- 24 would not have been [prosecuted or] convicted.
- 25 SECTION 4. Article 64.05, Code of Criminal Procedure, is
- 26 amended to read as follows:
- 27 Art. 64.05. APPEALS. An appeal [of a finding] under this

- 1 <u>chapter</u> [Article 64.03 or 64.04] is to a court of appeals <u>in the</u>
- 2 same manner as an appeal of any other criminal matter, except that
- 3 if the convicted person was convicted in a capital case and was
- 4 <u>sentenced to death</u>, the appeal of the finding is a direct appeal to
- 5 the court of criminal appeals.
- 6 SECTION 5. Article 44.01(a), Code of Criminal Procedure, is
- 7 amended to read as follows:
- 8 (a) The state is entitled to appeal an order of a court in a
- 9 criminal case if the order:
- 10 (1) dismisses an indictment, information, or
- 11 complaint or any portion of an indictment, information, or
- 12 complaint;
- 13 (2) arrests or modifies a judgment;
- 14 (3) grants a new trial;
- 15 (4) sustains a claim of former jeopardy; [or]
- 16 (5) grants a motion to suppress evidence, a
- 17 confession, or an admission, if jeopardy has not attached in the
- 18 case and if the prosecuting attorney certifies to the trial court
- 19 that the appeal is not taken for the purpose of delay and that the
- 20 evidence, confession, or admission is of substantial importance in
- 21 the case; or
- 22 <u>(6) is issued under Chapter 64</u>.
- 23 SECTION 6. The change in law made by this Act applies only
- to a convicted person who on or after the effective date of this Act
- 25 submits a motion for forensic DNA testing of evidence under Article
- 26 64.01, Code of Criminal Procedure, as amended by this Act. A
- 27 convicted person who submits a motion under Article 64.01 before

- 1 the effective date of this Act is covered by the law in effect when
- 2 the motion was submitted, and the former law is continued in effect
- 3 for that purpose.
- 4 SECTION 7. This Act takes effect September 1, 2003.
