- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subtitle A, Title 14, Occupations Code, is 6 amended by adding Chapter 2306 to read as follows:
- 7 CHAPTER 2306. INSURER INTERESTS IN REPAIR FACILITIES PROHIBITED
- 8 Sec. 2306.001. DEFINITIONS. In this chapter:
- 9 (1) "Insurer" means an insurer authorized by the Texas
- 10 Department of Insurance to write motor vehicle insurance in this
- 11 state, including a county mutual insurance company, a Lloyd's plan,
- 12 and a reciprocal or interinsurance exchange. The term includes an
- 13 entity that is an affiliate of an insurer as described by Section
- 14 <u>823.003</u>, Insurance Code.
- 15 (2) "Repair facility" has the meaning assigned by
- 16 Section 2304.001.

- 17 Sec. 2306.002. INTEREST PROHIBITED. An insurer may not
- 18 hold or acquire any ownership interest in a repair facility.
- 19 Sec. 2306.003. ACTION TO COMPEL COMPLIANCE. (a) An
- 20 <u>individual aggrieved by a violation of this chapter by an insurer</u>
- 21 may bring an action for injuctive or other appropriate relief to
- 22 compel the insurer to comply with the requirements adopted under
- this chapter.
- 24 (b) A plaintiff who prevails in an action under this section

- is entitled to recover reasonable attorney's fees and court costs.
- 2 Sec. 2306.004. DIVESTITURE REQUIREMENTS; DISCLOSURE. (a)
- 3 An insurer that, on September 1, 2003, has an ownership interest in
- 4 a repair facility must divest itself of any interest in the facility
- 5 not later than September 1, 2005.
- 6 (b) During the period in which the insurer maintains its
- 7 interest in the repair facility before the divestiture required
- 8 under this section, the insurer shall disclose to each insured that
- 9 the insured has the right to use any repair facility selected by the
- 10 <u>insured</u>. The insurer shall make the disclosure in writing in the
- 11 manner prescribed by the commissioner of insurance and shall
- 12 provide the disclosure:
- 13 <u>(1)</u> at the time the policy is delivered, issued for
- 14 delivery, or renewed; and
- 15 (2) when a claim covered by the policy is reported to
- the insurer by the insured.
- 17 (c) This section expires December 1, 2005.
- 18 SECTION 2. Chapter 2306, Occupations Code, as added by this
- 19 Act, applies only to an action that is commenced on or after the
- 20 effective date of this Act. An action that is commenced before the
- 21 effective date of this Act is governed by the law applicable to the
- 22 action immediately before the effective date of this Act, and that
- law is continued in effect for that purpose.
- SECTION 3. (a) Except as provided by Subsection (b) of this
- 25 section, this Act takes effect September 1, 2003.
- 26 (b) Section 2306.003, Occupations Code, as added by this
- 27 Act, takes effect September 1, 2005.
