A BILL TO BE ENTITLED

AN ACT

- 2 relating to the financing of certain local water, conservation, and
- 3 open-space projects in accordance with the law governing sports and
- 4 community venue projects.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 334.001(4), Local Government Code, is
- 7 amended to read as follows:
- 8 (4) "Venue" means:
- 9 (A) an arena, coliseum, stadium, or other type of
- 10 area or facility:

- 11 (i) that is used or is planned for use for
- 12 one or more professional or amateur sports events, community
- 13 events, or other sports events, including rodeos, livestock shows,
- 14 agricultural expositions, promotional events, and other civic or
- 15 charitable events; and
- 16 (ii) for which a fee for admission to the
- 17 events is charged or is planned to be charged;
- 18 (B) a convention center facility or related
- 19 improvement such as a convention center, civic center, civic center
- 20 building, civic center hotel, auditorium, theater, opera house,
- 21 music hall, exhibition hall, rehearsal hall, park, zoological park,
- 22 museum, aquarium, or plaza located in the vicinity of a convention
- center or facility owned by a municipality or a county;
- (C) a tourist development area along an inland

- 1 waterway;
- 2 (D) a municipal parks and recreation system, or
- 3 improvements or additions to a parks and recreation system, or an
- 4 area or facility that is part of a municipal parks and recreation
- 5 system; [and]
- (E) a project authorized by Section 4A or 4B,
- 7 Development Corporation Act of 1979 (Article 5190.6, Vernon's Texas
- 8 Civil Statutes), as that Act existed on September 1, 1997; and
- 9 (F) a watershed protection and preservation
- 10 project, a conservation easement, an open-space preservation
- 11 program intended to protect water, or any water project authorized
- 12 for a municipality under Chapter 401 or under the Water Code.
- 13 SECTION 2. Section 334.081, Local Government Code, is
- 14 amended by adding Subsection (d) to read as follows:
- (d) Subsection (c)(1) does not apply to a venue project for
- a venue described by Section 334.001(4)(F).
- 17 SECTION 3. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2003.
