## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the punishment for certain theft and fraud offenses 3 committed against an elderly individual.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 31, Penal Code, is amended by adding
- 6 Section 31.015 to read as follows:
- 7 Sec. 31.015. ENHANCED PUNISHMENT FOR OFFENSE COMMITTED
- 8 AGAINST ELDERLY INDIVIDUAL. (a) In this section:
- 9 (1) "Elderly individual" has the meaning assigned by
- 10 Section 22.04(c).

- 13 <u>occurs in this state.</u>
- 14 (b) An offense under this chapter, other than an offense

- 19 <u>(2) the discernible victim of the offense is an</u>

- SECTION 3. (a) This Act takes effect September 1, 2003.
- 14 (b) The change in law made by this Act applies only to an
- 15 offense committed on or after the effective date of this Act. An
- offense committed before the effective date of this Act is covered
- 17 by the law in effect when the offense was committed, and the former
- 18 law is continued in effect for that purpose. For purposes of this
- 19 section, an offense was committed before the effective date of this
- 20 Act if any element of the offense was committed before that date.
