- 5 SECTION 1. Section 901.006, Occupations Code, is amended to

- 7 Sec. 901.006. APPLICATION OF SUNSET ACT. The Texas State
- 8 Board of Public Accountancy is subject to Chapter 325, Government
- 9 Code (Texas Sunset Act). Unless continued in existence as provided
- 10 by that chapter, the board is abolished and this chapter expires
- 11 September 1, 2015  $[\frac{2003}{2}]$ .
- 12 SECTION 2. Section 901.053, Occupations Code, is amended to
- 13 read as follows:
- 14 Sec. 901.053. MEMBERSHIP AND EMPLOYEE RESTRICTIONS. (a)
- 15 In this section, "Texas trade association" means a [nonprofit,]
- 16 cooperative  $[\tau]$  and voluntarily joined statewide association of
- 17 business or professional competitors in this state designed to
- 18 assist its members and its industry or profession in dealing with
- 19 mutual business or professional problems and in promoting their
- 20 common interest.
- 21 (b) A person may not be a member of the board and may not be a
- 22 board employee employed in a "bona fide executive, administrative,
- or professional capacity," as that phrase is used for purposes of
- 24 establishing an exemption to the overtime provisions of the federal

- 6 \$100,000 [\$1,000] for each violation.
- 7 <u>(c) The board by rule shall adopt a schedule for purposes of</u>
- 8 this subchapter that prescribes ranges in the amounts of
- 9 administrative penalties to be imposed for specified types of
- 10 conduct and circumstances.
- 11 SECTION 24. Section 901.601, Occupations Code, is amended
- 12 to read as follows:
- Sec. 901.601. CEASE AND DESIST ORDER [INJUNCTION]. (a) If
- 14 it appears to the board that a person is [The board may bring an
- 15 action to enjoin a person from:
- 16 [(1) using a title, designation, or abbreviation in
- 17 violation of Subchapter J; or
- 18  $\left[\frac{(2)}{2}\right]$  engaging in an act or practice that constitutes
- 19 the practice of public accountancy without a license[, unless the
- 20 person is licensed] under this chapter, the board, after notice and
- 21 an opportunity for a hearing, may issue a cease and desist order
- 22 prohibiting the person from engaging in that activity.
- 23 (b) A violation of an order under this section constitutes
- 24 grounds for imposition of an administrative penalty under
- 25 Subchapter L. Notwithstanding Section 901.552, the amount of an
- 26 administrative penalty for a violation of an order under this
- 27 section may not exceed \$25,000. [An action under Subsection (a)(1)

- 1 must be brought in district court in:
- 2 [(1) Travis County, if the person is licensed under
- 3 this chapter or is not a resident of this state; or
- 4 [(2) the county in which the person resides, if the
- 5 person is a resident of this state but is not licensed under this
- 6 <del>chapter.</del>]
- 7 (c) The board by rule shall adopt a schedule for purposes of
- 8 this section that prescribes ranges in the amounts of
- 9 administrative penalties to be imposed for specified types of
- 10 conduct and circumstances that violate an order under this section.
- 11 [An action under Subsection (a)(2) must be brought in district
- 12 court in a county in which the person resides or has an office. The
- 13 board is not required to post a bond as a condition to the issuance
- 14 of the injunction.
- SECTION 25. Subchapter M, Chapter 901, Occupations Code, is
- amended by adding Section 901.6015 to read as follows:
- Sec. 901.6015. RESTITUTION. (a) The board may order a
- 18 <u>license holder to pay restitution under Section 901.501(a)(10)</u> to a
- 19 person harmed by the license holder's:
- 20 (1) violation of this chapter; and
- 21 (2) failure to fulfill the terms of a contract with the
- 22 <u>person.</u>
- 23 (b) The amount of restitution ordered under this section may
- 24 not exceed the actual amount paid by the person to the license
- 25 holder under the contract.
- SECTION 26. Section 901.602(b), Occupations Code, is
- 27 amended to read as follows:

- 1 (b) Except as otherwise provided by this subsection, an [An]
- 2 offense under this section is a Class B misdemeanor. An offense
- 3 under this section that involves intentional fraud is punishable
- 4 as:
- 5 (1) a felony of the third degree if it is shown on the
- 6 trial of the offense that the violation resulted in a monetary loss
- 7 of less than \$10,000 or did not result in a monetary loss;
- 8 (2) a felony of the second degree if it is shown on the
- 9 trial of the offense that the violation resulted in a monetary loss
- of at least \$10,000 but less than \$100,000; and
- 11 (3) a felony of the first degree if it is shown on the
- 12 trial of the offense that the violation resulted in a monetary loss
- 13 of at least \$100,000.
- SECTION 27. Subchapter M, Chapter 901, Occupations Code, is
- amended by adding Section 901.606 to read as follows:
- Sec. 901.606. IMMUNITY FROM LIABILITY. (a) A person acting
- 17 in good faith who voluntarily reports or assists in the
- investigation of a report of an alleged violation of this chapter or
- 19 who testifies or otherwise participates in an administrative or
- 20 judicial proceeding arising from a report or investigation of an
- 21 alleged violation of this chapter is immune from civil or criminal
- 22 liability that might otherwise be incurred or imposed.
- 23 (b) A person who reports the person's own violation of this
- 24 chapter or who acts in bad faith or with malicious purpose in
- 25 reporting an alleged violation of this chapter is not immune from
- 26 civil or criminal liability.
- SECTION 28. Section 901.304(b), Occupations Code, is

- 1 repealed.
- 2 SECTION 29. The Texas State Board of Public Accountancy
- 3 shall report to the governor, the lieutenant governor, and the
- 4 speaker of the house of representatives, not later than December
- 5 31, 2005, regarding:
- 6 (1) the requirements of the federal Sarbanes-Oxley Act
- 7 (Pub. L. No. 107-204), including any restrictions on public
- 8 interest entities, and any legislation or other action needed to
- 9 conform state law to the requirements of that Act;
- 10 (2) the federal General Accounting Office study on
- 11 audit firm rotation and any legislation or other action needed to
- 12 conform state law to the findings of that study; and
- 13 (3) the rules adopted by the board that are intended to
- comply with the federal standards described by Subdivisions (1) and
- 15 (2) of this section and the board's actions in implementing and
- 16 enforcing those rules.
- 17 SECTION 30. This Act takes effect September 1, 2003.
- 18 SECTION 31. (a) The Texas State Board of Public
- 19 Accountancy shall adopt rules as required by this Act not later than

- 21 (b) The changes in law made by this Act by Section 901.053,
- Occupations Code, as amended by this Act, and Section 901.059,
- Occupations Code, as added by this Act, in the prohibitions on or
- 24 qualifications of members of the Texas State Board of Public
- 25 Accountancy do not affect the entitlement of a member serving on the
- 26 board immediately before September 1, 2003, to continue to serve
- 27 and function as a member of the board for the remainder of the

- 1 member's term. Those changes in law apply only to a member 2 appointed on or after September 1, 2003.
- The change in law made by this Act with respect to conduct that is grounds for imposition of a disciplinary sanction, including an administrative penalty, restitution, or a cease and desist order, applies to conduct that occurs on or after the effective date of this Act. Conduct that occurs before the effective date of this Act is governed by the law in effect on the date the conduct occurred, and the former law is continued in effect for that purpose.

- (d) The change in law made by this Act by the addition of Section 901.606, Occupations Code, applies only to the immunity or liability of a person who voluntarily reports or assists in the investigation of a report of an alleged violation of Chapter 901, Occupations Code, or who testifies or otherwise participates in an administrative or judicial proceeding arising from a report or investigation of an alleged violation of that chapter on or after the effective date of this Act. The immunity or liability of a person who makes a report, assists in an investigation, testifies, or otherwise participates in a proceeding before the effective date of this Act is governed by the law in effect at the time those activities occurred, and the former law is continued in effect for that purpose.
- SECTION 32. (a) The change in law made by this Act to Section 901.602, Occupations Code, applies only to an offense committed on or after the effective date of this Act. For purposes of this section, an offense is committed before the effective date

- of this Act if any element of the offense occurs before that date.

- 3 Act is covered by the law in effect when the offense was committed,
- 4 and the former law is continued in effect for that purpose.
