15	SECTION 3. The heading of Section 281.121, Health and
16	Safety Code, is amended to read as follows:
17	Sec. 281.121. TAXES TO PAY BONDS AND CERTIFICATES OF
18	OBLIGATION; TAX ASSESSMENT AND COLLECTION.
19	SECTION 4. Sections 281.121(a) and (c), Health and Safety
20	Code, are amended to read as follows:
21	(a) When the district issues bonds <u>or certificates of</u>
22	obligation payable from and secured by taxes under this chapter,
23	the commissioners court shall impose a tax for the benefit of the
24	district on all property subject to district taxation. The

No. 1234 commissioners court may impose the tax for the entire year in which 1 2 the district is created in order to finance initial district 3 operation and to pay bonds assumed by the district. 4 (c) The proceeds of the tax may be used: 5 (1) to pay the interest on and create a sinking fund 6 for bonds that may be assumed or issued by the district for hospital purposes in accordance with this chapter; 7 8 (2) to provide for the operation and maintenance of the hospital or hospital system; [and] 9 if requested by the board and approved by the 10 (3) commissioners court, to make further improvements and additions to 11 the hospital system, including acquiring necessary sites by 12 purchase, lease, or condemnation; and 13 (4) to pay for certificates of obligation issued under 14 15 Section 281.106 that are payable from and secured by taxes. 16 SECTION 5. Section 271.043(7), Local Government Code, is 17 amended to read as follows: (7) "Issuer" means a municipality, [or] county, or 18 hospital district established under Chapter 281, Health and Safety 19 Code. 20 21 SECTION 6. This Act takes effect September 1, 2003.
