A BILL TO BE ENTITLED

2 relating to indemnification by the state of physicians providing

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 104.001, Civil Practice and Remedies
- 6 Code, is amended to read as follows:
- 7 Sec. 104.001. STATE LIABILITY; PERSONS COVERED. In a cause
- 8 of action based on conduct described in Section 104.002, the state
- 9 shall indemnify the following persons, without regard to whether
- 10 the persons performed their services for compensation, for actual
- 11 damages, court costs, and attorney's fees adjudged against:
- 12 (1) an employee, a member of the governing board, or
- any other officer of a state agency, institution, or department;
- 14 (2) a former employee, former member of the governing
- 15 board, or any other former officer of a state agency, institution,
- 16 or department who was an employee or officer when the act or
- omission on which the damages are based occurred;
- 18 (3) a physician or psychiatrist licensed in this state
- 19 who was performing services under a contract with any state agency,
- 20 institution, or department or a racing official performing services
- 21 under a contract with the Texas Racing Commission when the act or
- omission on which the damages are based occurred;
- 23 (4) a chaplain or spiritual advisor who was performing
- 24 services under contract with the Texas Department of Criminal

- 1 Justice, the Texas Youth Commission, or the Texas Juvenile
- 2 Probation Commission when the act or omission on which the damages
- 3 are based occurred;
- 4 (5) a person serving on the governing board of a
- 5 foundation, corporation, or association at the request and on
- 6 behalf of an institution of higher education, as that term is
- 7 defined by Section 61.003(8), Education Code, not including a
- 8 public junior college;
- 9 (6) a state contractor who signed a waste manifest as
- 10 required by a state contract; [ex]
- 11 (7) a physician licensed in this state providing
- 12 <u>health care services to a patient as part of:</u>
- 13 <u>(A)</u> the medical assistance program under Chapter
- 32, Human Resources Code; or
- 15 (B) the state child health plan under Chapter 62,
- 16 <u>Health and Safety Code; or</u>
- 17 (8) the estate of a person listed in this section.
- 18 SECTION 2. The heading to Chapter 104, Civil Practice and
- 19 Remedies Code, is amended to read as follows:
- 20 CHAPTER 104. STATE LIABILITY FOR CONDUCT OF CERTAIN PERSONS
- 21 [PUBLIC SERVANTS]
- SECTION 3. This Act takes effect September 1, 2003, and
- 23 applies only to a cause of action that accrues on or after that
- 24 date. An action that accrued before the effective date of this Act
- is governed by the law applicable to the action immediately before
- 26 the effective date of this Act, and that law is continued in effect
- 27 for that purpose.
