21	preceding conviction and the second or subsequent conviction are
22	among the offenses listed in Section 12.42(c)(2)(A), Penal Code, or
23	the offense described by Section 21.11, Penal Code [for the

SECTION 2. (a) This Act takes effect September 1, 2003. 1 2 (b) The change in law made by this Act applies only to an offense committed on or after September 1, 2003. An offense 3 4 committed before September 1, 2003, is covered by the law in effect 5 when the offense was committed, and the former law is continued in effect for that purpose. For purposes of this subsection, an 6 offense was committed before September 1, 2003, if any element of 7 the offense was committed before that date. 8
