16	home-rule municipality that borders <u>on</u> the Gulf of Mexico and has a
17	population of more than 250,000 may use all or any portion of the
18	revenue derived from the municipal hotel occupancy tax from hotels
19	previously subject to a county hotel occupancy tax to clean and
20	maintain public beaches in the municipality.
21	(c) Notwithstanding any other provision of this chapter, a
22	municipality that has a population of less than 5,000 adjacent to a
23	home-rule city with a population of less than 80,000 may use all or
24	any portion of the revenue heretofore or hereafter derived from the

2	(1) to clean and maintain the beaches in the

4	(2) to provide beach security within the municipality;
5	(3) for any of the purposes permitted or allowed by
6	Section 1504.001, Government Code;

8	(5) to pay the principal of or interest on bonds or
9	notes issued for any of these purposes.
10	SECTION 2. Section 351.003(c), Tax Code, is amended to read
11	as follows:
12	(c) The rate in a municipality that borders on the Gulf of
13	Mexico and has a population of more than 250,000 or in a
14	municipality with a population of less than 5,000 adjacent to a
15	home-rule city with a population of less than 80,000 may not exceed
16	nine percent of the price paid for a room.
17	SECTION 3. This Act takes effect September 1, 2003.
