- 5 SECTION 1. Section 505.001, Occupations Code, is amended to

- 9 SECTION 2. Section 505.002, Occupations Code, is amended by

- 11 read as follows:
- 12 (3) "Council on Social Work Education" means the
- 13 national organization that is primarily responsible for the

- 16 (4-a) "Licensed baccalaureate social worker" means a
- 17 person who holds a baccalaureate social worker license issued by
- 18 the board under this chapter.
- 19 "Licensed clinical social worker" means a person
- 20 who holds a clinical social worker license issued by the board under
- 21 this chapter.

Such provision may be located in the "Exceptions" or 11 "Exceptions and Reductions" provisions, or elsewhere in the policy, 12 or by endorsement attached to the policy, at the insurer's option. 13 14 In designating the practitioners who will and will not 15 recognized, such provision shall use the following terms: Doctor of Medicine, Doctor of Osteopathy, Doctor of Dentistry, Doctor of 16 17 Chiropractic, Doctor of Optometry, Doctor of Podiatry, Licensed Audiologist, Licensed Speech-language Pathologist, Doctor 18 19 Psychology, Licensed Clinical [Master] Social [Worker--Advanced Clinical Practitioner], Licensed Dietitian, 20 21 Licensed Professional Counselor, Licensed Marriage and Family Therapist, Licensed Chemical Dependency Counselor, Licensed 22 Hearing Instrument Fitter and Dispenser, Advanced Practice Nurse, 23 24 Physician Assistant, Licensed Occupational Therapist, Licensed 25 Physical Therapist, Licensed Acupuncturist, Licensed Psychological 26 Associate, and Licensed Surgical Assistant.
