- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 12.002, Education Code, is amended to
- 6 read as follows:
- 7 Sec. 12.002. CLASSES OF CHARTER. The classes of charter
- 8 under this chapter are:
- 9 (1) a home-rule school district charter as provided by
- 10 Subchapter B;
- 11 (2) a campus or campus program charter as provided by
- 12 Subchapter C; [or]
- 13 (3) an open-enrollment charter as provided by
- 14 Subchapter D; or
- 15 (4) a college or university charter as provided by
- 16 Subchapter E.
- SECTION 2. Sections 12.151-12.153, Education Code, are
- 18 amended to read as follows:
- 19 Sec. 12.151. DEFINITIONS [DEFINITION]. In this subchapter:
- 20 <u>(1) "Educational activity" means an activity of a</u>
- 21 student enrolled in a virtual charter school that is considered for
- 22 purposes of a student's minimum hours of instruction required by a
- 23 charter granted under this subchapter or rules adopted under this
- 24 subchapter.

- 1 (2) "Public [, "public] senior college or university"
- 2 has the meaning assigned by Section 61.003.
- 3 (3) "Virtual charter school" means a charter school
- 4 authorized and operating under this subchapter that uses
- 5 technology, including the Internet, to deliver a significant
- 6 portion of the school's instruction outside of a central campus.
- 7 Sec. 12.152. AUTHORIZATION. $[\frac{a}{a}]$ In accordance with this
- 8 subchapter and Subchapter D, the State Board of Education may grant
- 9 a charter on the application of a public senior college or
- 10 university for:
- 11 $\underline{\text{(1)}}$ an open-enrollment charter school to operate on
- 12 the campus of the public senior college or university or in the same
- 13 county in which the campus of the public senior college or
- 14 university is located; or
- 15 (2) a virtual charter school administered by a public
- 16 senior college or university to operate from an administrative
- 17 office in the same county in which the campus of the college or
- 18 university is located.
- 19 Sec. 12.153. RULES. (a) The commissioner may adopt rules
- 20 to implement this subchapter.
- 21 (b) The commissioner shall adopt rules to administer
- 22 virtual charter schools under this subchapter. For purposes of
- 23 <u>charter school funding under Section 12.106, the commissioner shall</u>
- 24 determine the number of hours of virtual charter school
- educational activities that are the equivalent of one day of school
- 26 attendance.
- 27 SECTION 3. Subchapter E, Chapter 12, Education Code, is

- 1 amended by adding Section 12.157 to read as follows:
- 2 Sec. 12.157. VIRTUAL CHARTER SCHOOL. (a) A virtual charter
- 3 school must:
- 4 (1) provide each student enrolled in the school with
- 5 access to a secular curriculum that meets or exceeds state academic
- 6 standards;
- 7 (2) allow each student to work at a grade level other
- 8 than the grade level in which the student is enrolled;
- 9 (3) at least once each week during the school year,
- 10 assess each student's performance in each subject in the foundation
- 11 curriculum in which the student is enrolled;
- 12 (4) ensure that a parent or legal guardian of each
- 13 student verifies the number of hours of educational activities
- 14 completed by the student each school year;
- 15 (5) make available to the parent or legal guardian of
- 16 each student:
- 17 (A) a computer and printer;
- 18 (B) physical copies of any instructional
- 19 materials related to the student's curriculum; and
- 20 (C) reimbursement for any fees related to
- 21 Internet access used for educational activities; and
- 22 (6) maintain a student/teacher ratio of not less than
- 23 <u>one teacher for each 60 students in average daily attendance.</u>
- 24 (b) A student enrolled in a virtual charter school shall
- 25 complete:
- 26 (1) at least 720 hours of educational activities each
- 27 school year if the student is enrolled in grade two or lower; and

- 1 (2) at least 900 hours of educational activities each
- 2 school year if the student is enrolled in grade three or higher.
- 3 (c) A teacher employed by a virtual charter school:
- 4 (1) must be appropriately certified under Subchapter
- 5 B, Chapter 21; and
- 6 (2) shall, at least four times each school year, be
- 7 <u>available to meet with the parent or legal guardian of each student</u>
- 8 enrolled in the teacher's class.
- 9 (d) A virtual charter school is entitled for each student in
- 10 average daily attendance to funding at a level equal to an
- 11 open-enrollment charter school.
- 12 (e) A public senior college or university that holds a
- 13 charter for a virtual charter school shall annually conduct an
- evaluation of the school, including an analysis of:
- 15 (1) any increase in student achievement, as measured
- 16 using state academic standards and standards described by the
- 17 charter;
- 18 <u>(2) the academic, fiscal, and operational performance</u>
- of the school; and
- 20 (3) the performance of any students who are assessed
- 21 using an assessment instrument adopted under Section 39.023.
- 22 SECTION 4. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2003.
