1 AN ACT relating to the telecommunications planning and oversight council. 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 3 SECTION 1. Sections 2054.201(a) and (b), Government Code, 4 5 are amended to read as follows: The telecommunications planning and oversight council 6 (a) is composed of: 7 8 a representative of the comptroller's office, (1) appointed by the comptroller; 9 (2) the executive director of the Telecommunications 10 11 Infrastructure Fund Board; 12 (3) a representative of the Texas Building and 13 Procurement Commission, appointed by the executive director of the 14 commission; (4) a member representing the interests of state 15 agencies with 1,000 employees or more, appointed by the lieutenant 16 governor; 17 (5) a member representing the interests of state 18 agencies with fewer than 1,000 employees, appointed by the speaker 19 of the house of representatives; 20 21 (6) a member representing the interests of 22 institutions of higher education, appointed by the commissioner of higher education; 23 24 (7) a member representing the interests of The

1 University of Texas System, appointed by the chancellor; 2 (8) a member representing the interests of The Texas 3 A&M University System, appointed by the chancellor; 4 (9) a member representing the interests of public districts that are customers of the consolidated 5 school telecommunications system, appointed by the governor; 6 7 (10)a member representing the interests of local 8 governments that are customers of the consolidated telecommunications system, appointed by the governor; [and] 9 two 10 (11)public members with telecommunications 11 expertise, appointed by the governor; and 12 (12) a representative of the Health and Human Services Commission, appointed by the commissioner of health and human 13 14 services. 15 (b) Appointed members of the telecommunications planning and oversight council serve staggered two-year terms, with the 16 17 terms of four or five members expiring August 31 each year, except that: 18 (1) the representative of the comptroller's office 19 serves at the discretion of the comptroller; 20 (2) [and] the representative of the Texas Building and 21 Procurement Commission serves at the discretion of the executive 22 director of the commission; and 23 24 (3) the representative of the Health and Human 25 Services Commission serves at the discretion of the commissioner of 26 health and human services. SECTION 2. Section 2054.206, Government Code, is amended to 27

1 read as follows:

2 Sec. 2054.206. ANNUAL REPORT. The telecommunications 3 planning and oversight council shall submit an annual report <u>not</u> 4 <u>later than November 1</u> to the department and to each entity served by 5 the consolidated telecommunications system or the centralized 6 capitol complex telephone system. The report must include:

7 (1) information about the accomplishment of service 8 objectives and other performance measures for management of the 9 consolidated telecommunications system and the centralized capitol 10 complex telephone system;

(2) information about the accounting and financial performance of the consolidated telecommunications system and the centralized capitol complex telephone system;

14 (3) estimates of savings to entities served by the 15 consolidated telecommunications system over standard rates 16 available to state agencies <u>that</u> [who] acquire telecommunications 17 services directly;

18 (4) trends in network use, including the number of19 users, workstations, and locations supported; and

20 (5) rate information for services provided by the 21 consolidated telecommunications system and the centralized capitol 22 complex telephone system.

23 SECTION 3. Subchapter H, Chapter 2054, Government Code, is 24 amended by adding Section 2054.2025 to read as follows:

25 <u>Sec. 2054.2025. LIMITATION OF LIABILITY. A member of the</u> 26 <u>telecommunications planning and oversight council is not liable in</u> 27 <u>a civil action for an act performed in good faith in the performance</u>

1 of the member's functions.

2 SECTION 4. Section 2054.205(c), Government Code, is 3 repealed.

4 SECTION 5. (a) When the terms of the members of the 5 telecommunications planning and oversight council first expire 6 after the effective date of this Act:

7 (1) the lieutenant governor and the speaker of the
8 house of representatives shall each appoint one member, and the
9 governor shall appoint two members, according to Section 2054.201,
10 Government Code, for terms expiring on the first August 31
11 occurring after the effective date of this Act; and

12 (2) the commissioner of higher education, the 13 chancellor of The University of Texas System, and the chancellor of 14 The Texas A&M University System shall each appoint one member, and 15 the governor shall appoint two members, according to Section 16 2054.201, Government Code, for terms expiring on the second August 17 31 occurring after the effective date of this Act.

(b) Promptly after this Act takes effect, the commissioner
of health and human services shall appoint a representative to the
telecommunications planning and oversight council.

21 SECTION 6. This Act takes effect immediately if it receives 22 a vote of two-thirds of all the members elected to each house, as 23 provided by Section 39, Article III, Texas Constitution. If this 24 Act does not receive the vote necessary for immediate effect, this 25 Act takes effect September 1, 2003.
