No. 1769 (a) Except as provided by Subsections (b), [and] (d), and 1 (e), this chapter does not apply to an individual employed in an 2 employee-employer relationship exclusively and regularly by one 3 employer in connection with the affairs of the employer. 4 5 This chapter applies to an individual described by (d) 6 Subsection (a) who[+ 7 [(1) works at a location that is open to the public; 8 and 9 [(2)] in the course of employment: 10 (1) [<del>(A) regularly</del>] comes into contact with the public; [and] 11 (2) [(B)] wears a uniform with any type of badge 12 commonly associated with security personnel or law enforcement or a 13 patch or apparel with "security" [or the name of the employer] on 14 15 the patch or apparel; or (3) performs a duty described by Section 1702.222. 16 17 (e) This chapter applies to any person who conducts an investigation if the investigation involves a person, or the 18 affairs of a person, who is not employed by the same employer as the 19 person conducting the investigation and the investigation is not 20 21 conducted on the premises of the employer. a license, certification, registration, commission, or letter of authority that is originally issued or renewed on or after the effective date of this Act. An issuance or renewal that occurs before the effective date of this Act is governed by the law in effect immediately before the effective date of this Act, and the former law is continued in effect for that purpose.

SECTION 6. This Act takes effect September 1, 2003.
