H.B. No. 1778

A BILL TO BE ENTITLED

AN ACT

1
2 relating to access to birth records under the public information
3 law.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 552.115(a), Government Code, is amended
6 to read as follows:

7 (a) A birth or death record maintained by the bureau of
8 vital statistics of the Texas Department of Health or a local
9 registration official is excepted from the requirements of Section
10 552.021, except that:

11 (1) a birth record is public information and available
12 to the public on and after the 75th [~~50th~~] anniversary of the date
13 of birth as shown on the record filed with the bureau of vital
14 statistics or local registration official;

15 (2) a death record is public information and available
16 to the public on and after the 25th anniversary of the date of death
17 as shown on the record filed with the bureau of vital statistics or
18 local registration official;

19 (3) a general birth index or a general death index
20 established or maintained by the bureau of vital statistics or a
21 local registration official is public information and available to
22 the public to the extent the index relates to a birth record or
23 death record that is public information and available to the public
24 under Subdivision (1) or (2);

1 (4) a summary birth index or a summary death index
2 prepared or maintained by the bureau of vital statistics or a local
3 registration official is public information and available to the
4 public; and

5 (5) a birth or death record is available to the chief
6 executive officer of a home-rule municipality or the officer's
7 designee if:

8 (A) the record is used only to identify a
9 property owner or other person to whom the municipality is required
10 to give notice when enforcing a state statute or an ordinance;

11 (B) the municipality has exercised due diligence
12 in the manner described by Section 54.035(e), Local Government
13 Code, to identify the person; and

14 (C) the officer or designee signs a
15 confidentiality agreement that requires that:

16 (i) the information not be disclosed
17 outside the office of the officer or designee, or within the office
18 for a purpose other than the purpose described by Paragraph (A);

19 (ii) the information be labeled as
20 confidential;

21 (iii) the information be kept securely; and

22 (iv) the number of copies made of the
23 information or the notes taken from the information that implicate
24 the confidential nature of the information be controlled, with all
25 copies or notes that are not destroyed or returned remaining
26 confidential and subject to the confidentiality agreement.

27 SECTION 2. Section 191.004(c), Local Government Code, is

1 amended to read as follows:

2 (c) Subsection (a) does not apply to birth and death records
3 maintained under the vital statistics laws of this state as
4 provided by Title 3, Health and Safety Code [~~Chapter 41, Acts of the~~
5 ~~40th Legislature, 1st Called Session, 1927 (Rules 34a-55a, Article~~
6 ~~4477, Vernon's Texas Civil Statutes)~~]. The [~~county clerk shall~~
7 ~~allow access to and give attested copies of a birth record on and~~
8 ~~after the 50th anniversary of the date on which it is filed and~~
9 ~~shall allow access to and give attested copies of a death record on~~
10 ~~and after the 25th anniversary of the date on which it is filed.~~
11 ~~Before that time, the~~] county clerk shall allow access to and give
12 attested copies of those records only as provided by the vital
13 statistics laws, ~~and~~ rules adopted under those laws, and Chapter
14 552, Government Code.

15 SECTION 3. This Act takes effect September 1, 2003.
