## A BILL TO BE ENTITLED 1 AN ACT 2 relating to exclusion from unemployment compensation an 3 chargebacks based on a separation from employment caused by certain 4 disasters. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Section 204.022(a), Labor Code, is amended to 6 read as follows: 7 Benefits computed on benefit wage credits of an employee 8 (a) or former employee may not be charged to the account of an employer 9 if the employee's last separation from the employer's employment 10 11 before the employee's benefit year: 12 (1) was required by a federal statute; 13 (2) was required by a statute of this state or an 14 ordinance of a municipality of this state; (3) would have disqualified the employee under Section 15 207.044, 207.045, 207.051, or 207.053 if the employment had been 16 the employee's last work; 17 18 (4) imposes a disqualification under Section 207.044, 207.045, 207.051, or 207.053; 19 (5) was caused by a medically verifiable illness of 20 21 the employee or the employee's minor child; 22 (6) was based on a natural disaster that results in a disaster declaration by the president of the United States under 23 the Robert T. Stafford Disaster Relief and Emergency Assistance Act 24

1 (42 U.S.C. Section 5121 et seq.), if the employee would have been 2 entitled to unemployment assistance benefits under Section 410 of 3 that act (42 U.S.C. Section 5177) had the employee not received 4 state unemployment compensation benefits;

5 (7) was caused by a natural disaster, fire, flood, or 6 explosion that causes employees to be separated from one employer's 7 employment; [<del>or</del>]

8 (8) resulted from the employee's resigning from 9 partial employment to accept other employment that the employee 10 reasonably believed would increase the employee's weekly wage<u>; or</u>

(9) was based on a disaster that results in a disaster 11 declaration by the governor under Section 418.014, Government Code. 12 SECTION 2. This Act applies only to a claim for unemployment 13 compensation benefits that is filed with the Texas Workforce 14 15 Commission on or after the effective date of this Act. A claim 16 filed before that date is governed by the law in effect on the date 17 the claim was filed, and the former law is continued in effect for that purpose. 18

19 SECTION 3. This Act takes effect immediately if it receives 20 a vote of two-thirds of all the members elected to each house, as 21 provided by Section 39, Article III, Texas Constitution. If this 22 Act does not receive the vote necessary for immediate effect, this 23 Act takes effect September 1, 2003.
