Section 46.002, Agriculture Code, is amended to read as follows: 10 Sec. 46.002. DEFINITION. 11 In this chapter "Texas 12 agricultural product" means an agricultural, apicultural, horticultural, silvicultural, viticultural, or vegetable product, 13 14 either in its natural or processed state, that has been produced, processed, or otherwise had value added to the product in this 15 state, including: 16 17 (1) [equine species; 18 [(2)] feed for use by livestock or poultry; (2) [(3)] fish or other aquatic species; 19 (3) [(4)] livestock, a livestock product, or 20 а 21 livestock by-product; 22 (4) [(5)] planting seed; (5) [(6)] poultry, a poultry product, or a poultry 23 24 by-product; or

<u>(6)</u> [(7)] wildlife processed for food or by-products.
 SECTION 3. Section 148.011(a), Agriculture Code, is amended
 to read as follows:

4 (a) In accordance with this section, a slaughterer shall 5 keep a record of all livestock [cattle, horses, hogs, sheep, or 6 goats] purchased or slaughtered. Both the slaughterer and the person managing the slaughtering operations are responsible for 7 8 maintaining records under this section. A person who owns or 9 operates a locker plant and leases, rents, or furnishes space to others in that plant for profit shall keep records in accordance 10 with this section as if that person were a slaughterer. 11

SECTION 4. Section 1.101(4), Parks and Wildlife Code, is amended to read as follows:

(4) "Wild," when used in reference to an animal, means
a species, including each individual of a species, that normally
lives in a state of nature and is not ordinarily domesticated. This
definition does not include exotic livestock defined by Section
<u>161.001(a)(4)</u> [<u>161.001(a)(3) and (4)</u>], Agriculture Code.

19 SECTION 5. Sections 53.001(3), 142.001(2), 147.001(2), and 20 161.001(a)(3), Agriculture Code, are repealed.
