6 (c) The change in law made by this Act relating to the 7 modification or enforcement of a child support order rendered 8 before the effective date of this Act applies only to a proceeding for modification or enforcement that is commenced on or after the 9 effective date of this Act. A proceeding for modification or 10 enforcement that is commenced before the effective date of this Act 11 is governed by the law in effect on the date the proceeding was 12 commenced, and the former law is continued in effect for that 13 14 purpose.

(d) The change in law made by this Act to Section 160.633, Family Code, applies to a suit affecting the parent-child relationship filed before, on, or after the effective date of this Act. A court order rendered before the effective date of this Act providing for the sealing of records in a proceeding is governed by the law in effect on the date the court order was rendered, and the former law is continued in effect for that purpose.
