BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 7

SECTION 1. Subchapter B, Chapter 55, Education Code, is 8

amended by adding Section 55.17421 to read as follows:

Sec. 55.17421. THE UNIVERSITY OF TEXAS SOUTHWESTERN MEDICAL 10

CENTER AT DALLAS; ADDITIONAL REVENUE BONDS. (a) In addition to the

other authority granted by this subchapter, the board of regents of

The University of Texas System may acquire, purchase, construct, 13

14 improve, renovate, enlarge, or equip property, buildings,

structures, or other facilities, including roads and related 15

infrastructure, for The University of Texas Southwestern Medical

Center at Dallas, to be used primarily to conduct biomedical 17

research and to be financed by the issuance of bonds in accordance

with this subchapter, including bonds issued in accordance with a 19

systemwide revenue financing program and secured as provided by 20

that program in an aggregate principal amount not to exceed \$56

Act takes effect September 1, 2003.
