## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to prohibiting the Texas Commission on Environmental
- 3 Quality from amending, interpreting, impairing, or modifying a
- 4 written contract for the wholesale provision of water.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 11.041, Water Code, is amended by
- 7 amending Subsection (a) and adding Subsection (h) to read as
- 8 follows:
- 9 (a) Any person entitled to receive or use water from any
- 10 canal, ditch, flume, lateral, dam, reservoir, or lake or from any
- 11 conserved or stored supply may present to the commission a written
- 12 petition showing:
- 13 (1) that he is entitled to receive or use the water;
- 14 (2) that he is willing and able to pay a just and
- 15 reasonable price for the water;
- 16 (3) that the party owning or controlling the water
- 17 supply has water not contracted to others and available for the
- 18 petitioner's use; [and]
- 19 (4) that the party owning or controlling the water
- 20 supply fails or refuses to supply the available water to the
- 21 petitioner, or that the price or rental demanded for the available
- 22 water is not reasonable and just or is discriminatory; and
- 23 <u>(5) that the petitioner has not entered into a</u>
- 24 contract with the party owning or controlling the water supply.

- 1 (h) Notwithstanding any other law, the commission may not
- 2 amend, interpret, impair, or modify a written contract for the
- 3 wholesale provision of water for any purpose provided by this
- 4 chapter or Chapter 12 or 13.
- 5 SECTION 2. Section 12.013, Water Code, is amended by adding
- 6 Subsection (i) to read as follows:
- 7 (i) Notwithstanding any other law, the commission may not
- 8 amend, interpret, impair, or modify a written contract for the
- 9 wholesale provision of raw or treated water for any purpose
- 10 provided by Chapter 11, this chapter, or Chapter 13.
- 11 SECTION 3. Section 13.041, Water Code, is amended by adding
- 12 Subsection (h) to read as follows:
- (h) Notwithstanding any other law, the commission may not
- 14 amend, interpret, impair, or modify a written contract for the
- wholesale provision of water for any purpose provided by Chapter 11
- or 12 or this chapter.
- 17 SECTION 4. The changes in law made by this Act apply only to
- 18 a contract executed on or after the effective date of this Act. A
- 19 contract executed before the effective date of this Act is governed
- 20 by the law in effect on the date the contract was executed, and the
- 21 former law is continued in effect for that purpose.
- 22 SECTION 5. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2003.
