3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subtitle B, Title 9, Property Code, is amended by
5	adding Chapter 116 to read as follows:
6	CHAPTER 116. UNIFORM PRINCIPAL AND INCOME ACT
7	SUBCHAPTER A. DEFINITIONS, FIDUCIARY DUTIES, AND OTHER
8	MISCELLANEOUS PROVISIONS
9	Sec. 116.001. SHORT TITLE. This chapter may be cited as
10	the Uniform Principal and Income Act.
11	Sec. 116.002. DEFINITIONS. In this chapter:
12	(1) "Accounting period" means a calendar year unless
13	another 12-month period is selected by a fiduciary. The term
14	includes a portion of a calendar year or other 12-month period that
15	begins when an income interest begins or ends when an income
16	interest ends.
17	(2) "Beneficiary" includes, in the case of a
18	decedent's estate, an heir, legatee, and devisee and, in the case of
19	a trust, an income beneficiary and a remainder beneficiary.
20	(3) "Fiduciary" means a personal representative or a
21	trustee. The term includes an executor, administrator, successor
22	personal representative, special administrator, and a person
23	performing substantially the same function.
24	(4) "Income" means money or property that a fiduciary

- 1 receives as current return from a principal asset. The term
- 2 includes a portion of receipts from a sale, exchange, or
- 3 liquidation of a principal asset, to the extent provided in
- 4 Subchapter D.
- 5 (5) "Income beneficiary" means a person to whom net
- 6 income of a trust is or may be payable.
- 7 (6) "Income interest" means the right of an income
- 8 beneficiary to receive all or part of net income, whether the terms
- 9 of the trust require it to be distributed or authorize it to be
- 10 <u>distributed in the trustee's discretion.</u>
- 11 (7) "Mandatory income interest" means the right of an
- income beneficiary to receive net income that the terms of the trust
- 13 require the fiduciary to distribute.
- 14 (8) "Net income" means the total receipts allocated to
- 15 income during an accounting period minus the disbursements made
- 16 from income during the period, plus or minus transfers under this
- 17 chapter to or from income during the period.
- 18 <u>(9) "Person" means an individual, corporation,</u>
- 19 <u>business trust, esta</u>te, trust, partnership, limited liability
- 20 company, association, joint venture, government; governmental
- 21 <u>subdivision</u>, agency, or instrumentality; public corporation, or
- 22 any other legal or commercial entity.
- 23 (10) "Principal" means property held in trust for
- 24 distribution to a remainder beneficiary when the trust terminates.
- 25 (11) "Remainder beneficiary" means a person entitled
- 26 to receive principal when an income interest ends.
- 27 (12) "Terms of a trust" means the manifestation of the

- 1 intent of a settlor or decedent with respect to the trust, expressed
- 2 in a manner that admits of its proof in a judicial proceeding,
- 3 whether by written or spoken words or by conduct.
- 4 (13) "Trustee" includes an original, additional, or
- 5 successor trustee, whether or not appointed or confirmed by a
- 6 court.
- 7 Sec. 116.003. UNIFORMITY OF APPLICATION AND CONSTRUCTION.
- 8 In applying and construing this Uniform Act, consideration must be
- 9 given to the need to promote uniformity of the law with respect to
- 10 <u>its subject matter among states that enact it.</u>
- 11 Sec. 116.004. FIDUCIARY DUTIES; GENERAL PRINCIPLES. (a)
- 12 In allocating receipts and disbursements to or between principal
- and income, and with respect to any matter within the scope of
- 14 Subchapters B and C, a fiduciary:
- 15 <u>(1)</u> shall administer a trust or estate in accordance
- with the terms of the trust or the will, even if there is a different
- 17 provision in this chapter;
- 18 (2) may administer a trust or estate by the exercise of
- 19 a discretionary power of administration given to the fiduciary by
- 20 the terms of the trust or the will, even if the exercise of the power
- 21 produces a result different from a result required or permitted by
- 22 this chapter;
- 23 <u>(3) shall administer a trust or estate in accordance</u>
- 24 with this chapter if the terms of the trust or the will do not
- 25 contain a different provision or do not give the fiduciary a
- 26 discretionary power of administration; and
- 27 <u>(4) shall add a receipt or charge a disbursement to</u>

- 1 principal to the extent that the terms of the trust and this chapter
- 2 do not provide a rule for allocating the receipt or disbursement to
- 3 or between principal and income.
- 4 (b) In exercising the power to adjust under Section
- 5 116.005(a) or a discretionary power of administration regarding a
- 6 matter within the scope of this chapter, whether granted by the
- 7 terms of a trust, a will, or this chapter, a fiduciary shall
- 8 administer a trust or estate impartially, based on what is fair and
- 9 reasonable to all of the beneficiaries, except to the extent that
- 10 the terms of the trust or the will clearly manifest an intention
- 11 that the fiduciary shall or may favor one or more of the
- 12 beneficiaries. A determination in accordance with this chapter is
- 13 presumed to be fair and reasonable to all of the beneficiaries.
- Sec. 116.005. TRUSTEE'S POWER TO ADJUST. (a) A trustee may
- 15 adjust between principal and income to the extent the trustee
- 16 considers necessary if the trustee invests and manages trust assets
- 17 as a prudent investor, the terms of the trust describe the amount
- that may or must be distributed to a beneficiary by referring to the
- 19 trust's income, and the trustee determines, after applying the
- 20 rules in Section 116.004(a), that the trustee is unable to comply
- 21 with Section 116.004(b). The power to adjust conferred by this
- 22 subsection includes the power to allocate all or part of a capital
- 23 gain to trust income.
- 24 (b) In deciding whether and to what extent to exercise the
- 25 power conferred by Subsection (a), a trustee shall consider all
- 26 factors relevant to the trust and its beneficiaries, including the
- 27 following factors to the extent they are relevant:

1	(1) the nature, purpose, and expected duration of the
2	trust;
3	(2) the intent of the settlor;
4	(3) the identity and circumstances of the
5	beneficiaries;
6	(4) the needs for liquidity, regularity of income, and
7	preservation and appreciation of capital;
8	(5) the assets held in the trust; the extent to which
9	they consist of financial assets, interests in closely held
10	enterprises, tangible and intangible personal property, or real
11	property; the extent to which an asset is used by a beneficiary; and
12	whether an asset was purchased by the trustee or received from the
13	settlor;
14	(6) the net amount allocated to income under the other
15	sections of this chapter and the increase or decrease in the value
16	of the principal assets, which the trustee may estimate as to assets
17	for which market values are not readily available;
18	(7) whether and to what extent the terms of the trust
19	give the trustee the power to invade principal or accumulate income
20	or prohibit the trustee from invading principal or accumulating
21	income, and the extent to which the trustee has exercised a power
22	from time to time to invade principal or accumulate income;
23	(8) the actual and anticipated effect of economic
24	conditions on principal and income and effects of inflation and
25	deflation; and
26	(9) the anticipated tax consequences of an adjustment.
27	(c) A trustee may not make an adjustment:

- (1) that diminishes the income interest in a trust
 that requires all of the income to be paid at least annually to a
 spouse and for which an estate tax or gift tax marital deduction
 would be allowed, in whole or in part, if the trustee did not have
 the power to make the adjustment;
- 6 (2) that reduces the actuarial value of the income
 7 interest in a trust to which a person transfers property with the
 8 intent to qualify for a gift tax exclusion;
- 9 (3) that changes the amount payable to a beneficiary

 10 as a fixed annuity or a fixed fraction of the value of the trust

 11 assets;
- (4) from any amount that is permanently set aside for charitable purposes under a will or the terms of a trust unless both income and principal are so set aside;

- (5) if possessing or exercising the power to make an adjustment causes an individual to be treated as the owner of all or part of the trust for income tax purposes, and the individual would not be treated as the owner if the trustee did not possess the power to make an adjustment;
- 20 (6) if possessing or exercising the power to make an
 21 adjustment causes all or part of the trust assets to be included for
 22 estate tax purposes in the estate of an individual who has the power
 23 to remove a trustee or appoint a trustee, or both, and the assets
 24 would not be included in the estate of the individual if the trustee
 25 did not possess the power to make an adjustment;
- 26 (7) if the trustee is a beneficiary of the trust; or
- 27 (8) if the trustee is not a beneficiary, but the

- 1 adjustment would benefit the trustee directly or indirectly.
- 2 (d) If Subsection (c)(5), (6), (7), or (8) applies to a

 3 trustee and there is more than one trustee, a cotrustee to whom the

 4 provision does not apply may make the adjustment unless the

 5 exercise of the power by the remaining trustee or trustees is not
- 6 permitted by the terms of the trust.

- 7 (e) A trustee may release the entire power conferred by 8 Subsection (a) or may release only the power to adjust from income 9 to principal or the power to adjust from principal to income if the trustee is uncertain about whether possessing or exercising the 10 power will cause a result described in Subsection (c)(1)-(6) or 11 12 (c)(8) or if the trustee determines that possessing or exercising the power will or may deprive the trust of a tax benefit or impose a 13 tax burden not described in Subsection (c). The release may be 14 15 permanent or for a specified period, including a period measured by 16 the life of an individual.
 - (f) Terms of a trust that limit the power of a trustee to make an adjustment between principal and income do not affect the application of this section unless it is clear from the terms of the trust that the terms are intended to deny the trustee the power of adjustment conferred by Subsection (a).
- Sec. 116.006. JUDICIAL CONTROL OF DISCRETIONARY POWER. (a)

 The court may not order a fiduciary to change a decision to exercise

 or not to exercise a discretionary power conferred by this chapter

 unless the court determines that the decision was an abuse of the

 fiduciary's discretion. A fiduciary's decision is not an abuse of

 discretion merely because the court would have exercised the power

- 1 <u>in a different manner or would not have exercised the power.</u>
- 2 (b) The decisions to which Subsection (a) applies include:
- 3 (1) a decision under Section 116.005(a) as to whether 4 and to what extent an amount should be transferred from principal to
- 5 income or from income to principal; and
- 6 (2) a decision regarding the factors that are relevant
- 7 to the trust and its beneficiaries, the extent to which the factors
- 8 are relevant, and the weight, if any, to be given to those factors,
- 9 in deciding whether and to what extent to exercise the
- discretionary power conferred by Section 116.005(a).
- 11 (c) If the court determines that a fiduciary has abused the
- 12 fiduciary's discretion, the court may place the income and
- 13 remainder beneficiaries in the positions they would have occupied
- 14 if the discretion had not been abused, according to the following
- 15 rules:
- 16 (1) to the extent that the abuse of discretion has
- 17 resulted in no distribution to a beneficiary or in a distribution
- that is too small, the court shall order the fiduciary to distribute
- 19 from the trust to the beneficiary an amount that the court
- 20 determines will restore the beneficiary, in whole or in part, to the
- 21 beneficiary's appropriate position;
- 22 (2) to the extent that the abuse of discretion has
- 23 <u>resulted in a distribution to a beneficiary which is too large, the</u>
- court shall place the beneficiaries, the trust, or both, in whole or
- 25 in part, in their appropriate positions by ordering the fiduciary
- 26 to withhold an amount from one or more future distributions to the
- 27 beneficiary who received the distribution that was too large or

- 1 ordering that beneficiary to return some or all of the distribution
- 2 to the trust; and
- 3 (3) to the extent that the court is unable, after
- 4 applying Subdivisions (1) and (2), to place the beneficiaries, the
- 5 trust, or both, in the positions they would have occupied if the
- 6 discretion had not been abused, the court may order the fiduciary to
- 7 pay an appropriate amount from its own funds to one or more of the
- 8 beneficiaries or the trust or both.
- 9 (d) Upon petition by the fiduciary, the court having
- 10 jurisdiction over a trust or estate shall determine whether a
- 11 proposed exercise or nonexercise by the fiduciary of a
- 12 discretionary power conferred by this chapter will result in an
- abuse of the fiduciary's discretion. If the petition describes the
- 14 proposed exercise or nonexercise of the power and contains
- 15 <u>sufficient information to inform the beneficiaries of the reasons</u>
- 16 for the proposal, the facts upon which the fiduciary relies, and an
- 17 <u>explanation of how the income and remainder beneficiaries will be</u>
- 18 affected by the proposed exercise or nonexercise of the power, a
- 19 beneficiary who challenges the proposed exercise or nonexercise has
- 20 the burden of establishing that it will result in an abuse of
- 21 <u>discretion</u>.
- Sec. 116.007. PROVISIONS REGARDING NONCHARITABLE
- 23 UNITRUSTS. (a) This section does not apply to a charitable
- remainder unitrust as defined by Section 664(d), Internal Revenue
- 25 Code of 1986 (26 U.S.C. Section 664), as amended.
- 26 (b) In this section:
- 27 (1) "Unitrust" means a trust the terms of which

2	(2) "Unitrust amount" means a distribution mandated by
3	the terms of a trust in an amount equal to a fixed percentage of not
4	less than three or more than five percent per year of the net fair
5	market value of the trust's assets, valued at least annually. The
6	unitrust amount may be determined by reference to the net fair
7	market value of the trust's assets in one year or more than one
8	<u>year.</u>
9	(c) Distribution of the unitrust amount is considered a
10	distribution of all of the income of the unitrust and shall not be
11	considered a fundamental departure from applicable state law. A
12	distribution of the unitrust amount reasonably apportions the total
13	return of a unitrust.
14	(d) Unless the terms of the trust specifically provide
15	otherwise, a distribution of the unitrust amount shall be treated
16	as first being made from the following sources in order of priority:
17	(1) from net accounting income determined as if the
18	trust were not a unitrust;
19	(2) from ordinary accounting income not allocable to
20	net accounting income;
21	(3) from net realized short-term capital gains;
22	(4) from net realized long-term capital gains; and
23	(5) from the principal of the trust estate.

25	SUBCHAPTER B. DECEDENT'S ESTATE OR
26	TERMINATING INCOME INTEREST
27	Sec. 116.051. DETERMINATION AND DISTRIBUTION OF NET INCOME.

1 require distribution of a unitrust amount.

- 1 After a decedent dies, in the case of an estate, or after an income
- 2 interest in a trust ends, the following rules apply:
- 3 (1) A fiduciary of an estate or of a terminating income
- 4 interest shall determine the amount of net income and net principal
- 5 receipts received from property specifically given to a beneficiary
- 6 under the rules in Subchapters C, D, and E which apply to trustees
- 7 and the rules in Subdivision (5). The fiduciary shall distribute
- 8 the net income and net principal receipts to the beneficiary who is
- 9 to receive the specific property.
- 10 (2) A fiduciary shall determine the remaining net
- 11 <u>income of a decedent's estate or a terminating income interest</u>
- 12 under the rules in Subchapters C, D, and E which apply to trustees
- 13 and by:
- 14 (A) including in net income all income from
- 15 property used to discharge liabilities;
- 16 (B) paying from income or principal, in the
- 17 <u>fiduciary's discretion</u>, fees of attorneys, accountants, and
- 18 fiduciaries; court costs and other expenses of administration; and
- 19 interest on death taxes, but the fiduciary may pay those expenses
- 20 from income of property passing to a trust for which the fiduciary
- 21 <u>claims an estate tax marital or charitable deduction only to the</u>
- 22 extent that the payment of those expenses from income will not cause
- 23 the reduction or loss of the deduction; and
- (C) paying from principal all other
- 25 disbursements made or incurred in connection with the settlement of
- 26 <u>a decedent's estate or the winding up of a terminating income</u>
- 27 interest, including debts, funeral expenses, disposition of

- 1 remains, family allowances, and death taxes and related penalties
- 2 that are apportioned to the estate or terminating income interest
- 3 by the will, the terms of the trust, or applicable law.
- 4 (3) A fiduciary shall distribute to a beneficiary who
 5 receives a pecuniary amount outright the interest or any other
- 6 amount provided by the will, the terms of the trust, or applicable
- 7 law from net income determined under Subdivision (2) or from
- 8 principal to the extent that net income is insufficient. If a
- 9 beneficiary is to receive a pecuniary amount outright from a trust
- 10 after an income interest ends and no interest or other amount is
- 11 provided for by the terms of the trust or applicable law, the
- 12 <u>fiduciary shall distribute the interest or other amount to which</u>
- 13 the beneficiary would be entitled under applicable law if the
- 14 pecuniary amount were required to be paid under a will. Unless
- 15 otherwise provided by the will or the terms of the trust, a
- 16 beneficiary who receives a pecuniary amount, regardless of whether
- in trust, shall be paid interest on the pecuniary amount at the
- 18 legal rate of interest as provided by Section 302.002, Finance
- 19 Code. Interest on the pecuniary amount is payable:
- 20 (A) under a will, beginning on the first
- 21 anniversary of the date of the decedent's death; or
- (B) under a trust, beginning on the first
- 23 anniversary of the date on which an income interest ends.
- 24 (4) A fiduciary shall distribute the net income
- 25 remaining after distributions required by Subdivision (3) in the
- 26 manner described in Section 116.052 to all other beneficiaries even
- 27 if the beneficiary holds an unqualified power to withdraw assets

1 from the trust or other presently exercisable general power of
2 appointment over the trust.

- receipts from property described in Subdivision (1) because of a payment described in Section 116.201 or 116.202 to the extent that the will, the terms of the trust, or applicable law requires the fiduciary to make the payment from assets other than the property or to the extent that the fiduciary recovers or expects to recover the payment from a third party. The net income and principal receipts from the property are determined by including all of the amounts the fiduciary receives or pays with respect to the property, whether those amounts accrued or became due before, on, or after the date of a decedent's death or an income interest's terminating event, and by making a reasonable provision for amounts that the fiduciary believes the estate or terminating income interest may become obligated to pay after the property is distributed.
- 17 (6) A fiduciary, without reduction for taxes, shall
 18 pay to a charitable organization that is entitled to receive income
 19 under Subdivision (4) any amount allowed as a tax deduction to the
 20 estate or trust for income payable to the charitable organization.
 - Sec. 116.052. DISTRIBUTION TO RESIDUARY AND REMAINDER BENEFICIARIES. (a) Each beneficiary described in Section 116.051(4) is entitled to receive a portion of the net income equal to the beneficiary's fractional interest in undistributed principal assets, using values as of the distribution date. If a fiduciary makes more than one distribution of assets to beneficiaries to whom this section applies, each beneficiary,

- 1 including one who does not receive part of the distribution, is
- 2 entitled, as of each distribution date, to the net income the
- 3 fiduciary has received after the date of death or terminating event
- 4 or earlier distribution date but has not distributed as of the
- 5 current distribution date.
- 6 (b) In determining a beneficiary's share of net income, the
 7 following rules apply:
- 8 (1) The beneficiary is entitled to receive a portion
- 9 of the net income equal to the beneficiary's fractional interest in
- 10 the undistributed principal assets immediately before the
- 11 distribution date, including assets that later may be sold to meet
- 12 principal obligations.
- 13 (2) The beneficiary's fractional interest in the
- 14 undistributed principal assets must be calculated without regard to
- property specifically given to a beneficiary and property required
- 16 <u>to pay pecuniary amounts not in trust.</u>
- 17 (3) The beneficiary's fractional interest in the
- 18 undistributed principal assets must be calculated on the basis of
- 19 the aggregate value of those assets as of the distribution date
- 20 without reducing the value by any unpaid principal obligation.
- 21 (4) The distribution date for purposes of this section
- 22 may be the date as of which the fiduciary calculates the value of
- 23 the assets if that date is reasonably near the date on which assets
- 24 are actually distributed.
- 25 (c) If a fiduciary does not distribute all of the collected
- 26 but undistributed net income to each person as of a distribution
- 27 date, the fiduciary shall maintain appropriate records showing the

- 1 <u>interest of each beneficiary in that net income.</u>
- 2 (d) A fiduciary may apply the rules in this section, to the
- 3 extent that the fiduciary considers it appropriate, to net gain or
- 4 loss realized after the date of death or terminating event or
- 5 earlier distribution date from the disposition of a principal asset
- 6 if this section applies to the income from the asset.
- 7 [Sections 116.053-116.100 reserved for expansion]
- 8 <u>SUBCHAPTER C. APPORTIONMENT AT BEGINNING</u>
- 9 AND END OF INCOME INTEREST
- Sec. 116.101. WHEN RIGHT TO INCOME BEGINS AND ENDS. (a) An
- income beneficiary is entitled to net income from the date on which
- 12 the income interest begins. An income interest begins on the date
- 13 specified in the terms of the trust or, if no date is specified, on
- 14 the date an asset becomes subject to a trust or successive income
- 15 interest.
- (b) An asset becomes subject to a trust:
- 17 (1) on the date it is transferred to the trust in the
- 18 case of an asset that is transferred to a trust during the
- 19 transferor's life;
- 20 (2) on the date of a testator's death in the case of an
- 21 asset that becomes subject to a trust by reason of a will, even if
- there is an intervening period of administration of the testator's
- 23 <u>estate; or</u>
- 24 (3) on the date of an individual's death in the case of
- 25 an asset that is transferred to a fiduciary by a third party because
- of the individual's death.
- 27 (c) An asset becomes subject to a successive income interest

- on the day after the preceding income interest ends, as determined
- 2 under Subsection (d), even if there is an intervening period of
- 3 administration to wind up the preceding income interest.
- 4 (d) An income interest ends on the day before an income
- 5 beneficiary dies or another terminating event occurs, or on the
- 6 last day of a period during which there is no beneficiary to whom a
- 7 <u>trustee may distribute income.</u>
- 8 Sec. 116.102. APPORTIONMENT OF RECEIPTS AND DISBURSEMENTS
- 9 WHEN DECEDENT DIES OR INCOME INTEREST BEGINS. (a) A trustee shall
- 10 allocate an income receipt or disbursement other than one to which
- 11 Section 116.051(1) applies to principal if its due date occurs
- 12 before a decedent dies in the case of an estate or before an income
- 13 <u>interest begins in the case of a trust or successive income</u>
- 14 interest.
- 15 (b) A trustee shall allocate an income receipt or
- 16 disbursement to income if its due date occurs on or after the date
- on which a decedent dies or an income interest begins and it is a
- 18 periodic due date. An income receipt or disbursement must be
- 19 treated as accruing from day to day if its due date is not periodic
- 20 or it has no due date. The portion of the receipt or disbursement
- 21 accruing before the date on which a decedent dies or an income
- 22 interest begins must be allocated to principal and the balance must
- 23 <u>be allocated to income.</u>
- (c) An item of income or an obligation is due on the date the
- 25 payer is required to make a payment. If a payment date is not
- 26 stated, there is no due date for the purposes of this chapter.
- 27 Distributions to shareholders or other owners from an entity to

- which Section 116.151 applies are deemed to be due on the date fixed
- 2 by the entity for determining who is entitled to receive the
- 3 distribution or, if no date is fixed, on the declaration date for
- 4 the distribution. A due date is periodic for receipts or
- 5 disbursements that must be paid at regular intervals under a lease
- 6 or an obligation to pay interest or if an entity customarily makes
- 7 <u>distributions at regular intervals.</u>
- 8 Sec. 116.103. APPORTIONMENT WHEN INCOME INTEREST ENDS. (a)
- 9 <u>In this section, "undistributed income" means net income received</u>
- 10 before the date on which an income interest ends. The term does not
- 11 include an item of income or expense that is due or accrued or net
- income that has been added or is required to be added to principal
- 13 under the terms of the trust.
- 14 (b) When a mandatory income interest ends, the trustee shall
- 15 pay to a mandatory income beneficiary who survives that date, or the
- 16 <u>estate of a deceased mandatory income beneficiary whose death</u>
- 17 causes the interest to end, the beneficiary's share of the
- 18 undistributed income that is not disposed of under the terms of the
- 19 trust unless the beneficiary has an unqualified power to revoke
- 20 more than five percent of the trust immediately before the income
- 21 <u>interest ends</u>. In the latter case, the undistributed income from
- 22 the portion of the trust that may be revoked must be added to
- 23 principal.
- (c) When a trustee's obligation to pay a fixed annuity or a
- 25 fixed fraction of the value of the trust's assets ends, the trustee
- 26 shall prorate the final payment if and to the extent required by
- 27 applicable law to accomplish a purpose of the trust or its settlor

1	relating to income, gift, estate, or other tax requirements.

3	SUBCHAPTER D. ALLOCATION OF RECEIPTS DURING

5	PART 1. RECEIPTS FROM ENTITIES
6	Sec. 116.151. CHARACTER OF RECEIPTS. (a) In this section,
7	"entity" means a corporation, partnership, limited liability

- Sec. 116.176. PROPERTY NOT PRODUCTIVE OF INCOME. (a) If a marital deduction is allowed for all or part of a trust whose assets consist substantially of property that does not provide the spouse with sufficient income from or use of the trust assets, and if the amounts that the trustee transfers from principal to income under Section 116.005 and distributes to the spouse from principal pursuant to the terms of the trust are insufficient to provide the spouse with the beneficial enjoyment required to obtain the marital deduction, the spouse may require the trustee to make property productive of income, convert property within a reasonable time, or exercise the power conferred by Section 116.005(a). The trustee may decide which action or combination of actions to take.
- 20 (b) In cases not governed by Subsection (a), proceeds from

- Sec. 116.177. DERIVATIVES AND OPTIONS. (a) In this

 section, "derivative" means a contract or financial instrument or a

- 2 or changes in a rate, an index of prices or rates, or other market
- 3 indicator for an asset or a group of assets.

- (a) Except as provided by Subsection (b) of this section and 10 unless the will provides otherwise, all expenses incurred in 11 connection with the settlement of a decedent's estate, including 12 debts, funeral expenses, estate taxes, [interest and] penalties 13 14 relating to estate taxes, and family allowances, shall be charged 15 against the principal of the estate. Fees and expenses of an attorney, accountant, or other professional advisor, commissions 16 17 and expenses of a personal representative, court costs, and all other similar fees or expenses relating to the administration of 18 19 the estate <u>and interest relating to estate taxes</u> shall be allocated between the income and principal of the estate as the executor 20 21 determines in its discretion to be just and equitable.
 - (b) Unless the will provides otherwise, income from the assets of a decedent's estate that accrues after the death of the testator and before distribution, including income from property used to discharge liabilities, shall be determined according to the rules applicable to a trustee under the Texas Trust Code (Subtitle B, Title 9, Property Code) and distributed as provided by Chapter

- 1 <u>116, Property Code, and</u> Subsections (c) <u>and</u> $[\tau]$ (d) $[\tau]$ and $[\tau]$ of this section.
- The [Except as provided by Subsection (f) of this 3 section, the] balance of the net income shall be distributed to all 4 5 other devisees after reduction for the balance of property taxes, ordinary repairs, insurance premiums, interest accrued, [including 6 interest accruing as provided by Subsection (f) of this section 7 8 after the death of the testator, other expenses of management and operation of all property from which the estate is entitled to 9 income, and taxes imposed on income that accrues during the period 10 of administration and that is payable or allocable to the devisees, 11 in proportion to the devisees' respective interests in the 12 undistributed assets of the estate. 13
