ARTICLE III

8 SECTION 1. In this Act, "tract" and "block" mean the 9 geographic areas identified by those terms on the 2000 Census 10 TIGER/Line File, prepared by the federal Bureau of the Census for 11 the Twenty-second Decennial Census of the United States, enumerated 12 as of April 1, 2000.

SECTION 2. It is the intention of the Texas Legislature 13 14 that, if any county, tract, block, or other geographic area has 15 erroneously been left out of this Act, a court reviewing this Act should include that area in the appropriate district in accordance 16 17 with the intent of the legislature, using any available evidence of that intent, including evidence such as that used by the Supreme 18 Court of Texas in Smith v. Patterson, 111 Tex. 535, 242 S.W. 749 19 (1922). 20

SECTION 3. The districts set out in Article II of this Act apply to the election of the members for those districts of the Texas House of Representatives beginning with the primary and general elections in 2004 for members of the 79th Legislature. This Act does not affect the membership or districts of the Texas House of Representatives of the 78th Legislature.

SECTION 4. This Act takes effect immediately if it receives

a vote of two-thirds of all the members elected to each house, as
provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2003.
