Sections 16.01(a) and (c), Alcoholic Beverage 4 5 Code, are amended to read as follows: The holder of a winery permit may: 6 (a) (1) manufacture, bottle, label, and package wine 7 containing not more than 24 percent alcohol by volume; 8 manufacture and import grape brandy for fortifying 9 (2) purposes only and to be used only on his licensed premises; 10 sell wine in this state to holders of wholesaler's 11 (3) 12 permits, winery permits, and wine bottler's permits; 13 (4) sell wine to ultimate consumers: 14 (A) for consumption on the winery premises; or 15 (B) in unbroken packages for off-premises consumption in an amount not to exceed 25,000 gallons annually; 16 (5) sell the wine outside this state to qualified 17 persons; 18 (6) blend wines; and 19 dispense free wine for consumption on the winery 20 (7) 21 premises. 22 (C) The holder of a winery permit may conduct wine 23 samplings, including wine tastings at a retailer's premises. Α 24 winery employee may open, touch, or pour wine, make a presentation,

or answer questions at a wine sampling. [A wine sampling may not be 1 held in a location where a wine sampling is otherwise prohibited by 2 <del>law.</del>] 3 4 SECTION 2. Chapter 16, Alcoholic Beverage Code, is amended by adding Section 16.011 to read as follows: 5 6 Sec. 16.011. PREMISES IN DRY AREA. A winery permit may be issued for premises in a dry area. A holder of a permit under this 7 8 section may: 9 (1) manufacture wine; and (2) sell or dispense wine to an ultimate consumer only 10 if the wine is: 11 12 (A) manufactured in this state; and (B) at least 75 percent by volume fermented juice 13 14 of grapes or other fruit grown in this state. 15 SECTION 3. Sections 16.01(d) and 16.05, Alcoholic Beverage Code, are repealed. 16 SECTION 4. This Act takes effect on the date on which the 17 constitutional amendment proposed by the 78th Legislature, Regular 18 Session, 2003, authorizing the holder of a winery permit to 19 manufacture and sell certain wine on the winery premises and to 20 dispense certain wine without charge for tasting on the winery 21 premises takes effect. If that amendment is not approved by the 22 23 voters, this Act has no effect.
