- 9 SECTION 2. Sections 91.115(a), (e), and (f), Natural

- 11 (a) If a responsible person fails to clean up a site or

- 13 commission's jurisdiction on or before the date the site or
- 14 facility is required to be cleaned up by law or by a rule adopted or
- order issued by the commission, the state has a first lien, superior
- 16 to all preexisting and subsequent liens and security interests, on

- 18 <u>site or facility and in any</u> equipment that is:

- 20 (2) used by the responsible person in connection with

- (e) The lien is extinguished as to any stored hydrocarbons
