- 9 (b) The commission is composed of <u>five</u> [six] members 10 appointed by the governor with the advice and consent of the senate.
- 11 SECTION 1.02. Effective September 1, 2003, Section 461.006,
- 12 Health and Safety Code, is amended to read as follows:
- Sec. 461.006. TERMS. Commission members serve staggered
- 14 six-year terms, with the terms of one or two members expiring
- 15 February 1 of each odd-numbered year.
- SECTION 1.03. (a) Of the two positions on the Texas
- 17 Commission on Alcohol and Drug Abuse that have terms scheduled to
- 18 expire on February 1, 2005, one of the positions is abolished on
- 19 September 1, 2003.

- 9 jurisdiction of the commission, one of whom must be employed by a

- 12 names submitted by the State Firemen's and Fire Marshals'
- 13 Association of Texas who are volunteer fire chiefs or volunteer
- 14 fire fighters;
- 15 (4) one certified fire protection engineer;
- 16 (5) one certified arson investigator or certified fire
- 17 protection inspector;
- 18 (6) one fire protection instructor from an institution
- of higher education as defined by Section 61.003, Education Code;
- 20 and
- 21 (7) four [three] public members.
- 22 (b) The members of the commission are appointed by the
- 23 governor with the advice and consent of the senate for staggered
- 24 terms of six years with four or five members' terms expiring
- 25 February 1 of each odd-numbered year.
- SECTION 10.02. As soon as possible on or after September 1,
- 27 2003, the governor shall appoint an additional public member to the

- 1 Texas Commission on Fire Protection for a term expiring on February

- 10 interest in the services provided by the department, and three
- 11 [two] members must represent the public.
- SECTION 11.02. Effective September 1, 2003, Section 11.007,
- 13 Health and Safety Code, is amended to read as follows:
- Sec. 11.007. TERMS. Board members serve for staggered
- 15 six-year terms, with the terms of two or three members expiring
- 16 February 1 of each odd-numbered year.
- 17 SECTION 11.03. As soon as possible on or after September 1,
- 18 2003, the governor shall appoint an additional public member to the
- 19 Texas Board of Health for a term expiring on February 1, 2009.
- 20 ARTICLE 12. TEXAS HEALTH BENEFITS PURCHASING COOPERATIVE
- 21 SECTION 12.01. Effective September 1, 2003, Articles
- 22 26.13(b) and (c), Insurance Code, are amended to read as follows:
- (b) The Texas cooperative is administered by a five-member
- 24 [six-member] board of trustees appointed by the governor with the
- 25 advice and consent of the senate. Two [Three] members must
- 26 represent employers, two members must represent employees, and one
- 27 member must represent the public.

- The appointed members of the board of trustees serve 1 2 staggered six-year terms, with the terms of one or two members 3 expiring February 1 of each odd-numbered year.
- 4 SECTION 12.02. The position of the employer member whose term on the board of trustees of the Texas Health Benefits 5 6 Purchasing Cooperative is scheduled to expire on February 1, 2005, is abolished on September 1, 2003. 7
- ARTICLE 13. TEXAS HIGHER EDUCATION COORDINATING BOARD 8 SECTION 13.01. Effective September 1, 2003, Section 61.022, 9 Education Code, is amended to read as follows:

- Sec. 61.022. MEMBERS OF BOARD; APPOINTMENT; TERMS OF OFFICE. The board shall consist of 15  $[\frac{18}{18}]$  members appointed by the governor so as to provide representation from all areas of the state with the advice and consent of the senate, and as the constitution provides. Members of the board serve staggered six-year terms. The terms of one-third of the members expire August 31 of each odd-numbered year. [Of the initial appointments to the board six shall be for terms which shall expire August 31, 1967, six for terms which shall expire August 31, 1969, and six for terms which shall expire on August 31, 1971, or at such time as their successors are appointed and have qualified. Thereafter, the governor shall appoint members for terms of six years. Members of the Texas Commission on Higher Education are eligible for appointment to the board. No member may be employed professionally for remuneration in the field of education during his term of office.
- SECTION 13.02. (a) Of the six positions on the Texas 26 Higher Education Coordinating Board that have terms scheduled to 27

- 1 expire on August 31, 2003, one of the positions is abolished on
- 2 September 1, 2003. On or before September 1, 2003, the governor

- 1 member must be a professional archeologist, one must be a
- 2 professional historian, and one must be a licensed architect who
- 3 has expertise in historic preservation and architectural history.
- 4 Fourteen [Fifteen] members must be representatives of the general
- 5 public. A person is not eligible for appointment as a public member
- of the commission if the person or the person's spouse:
- 7 (1) owns or controls, directly or indirectly, more
- 8 than a 10 percent interest in a business entity or other
- 9 organization regulated by the commission or receiving funds other
- 10 than grant funds from the commission; or
- 11 (2) uses or receives a substantial amount of tangible

- 23 (e) <u>Three</u> [<del>Four</del>] members of the board constitute a quorum
- 24 for the transaction of business.
- 25 SECTION 16.02. (a) Of the two positions on the Texas Board
- of Human Services that have terms scheduled to expire on January 20,
- 27 2005, one of the positions is abolished on September 1, 2003.

- (b) On or before September 1, 2003, the two members whose terms are scheduled to expire on January 20, 2005, shall determine by unanimous agreement or by lot which of the two positions shall be abolished on September 1, 2003, and shall inform the presiding officer of the Texas Board of Human Services of that determination.
- 6 ARTICLE 17. TEXAS BOARD OF PROFESSIONAL LAND SURVEYING
- SECTION 17.01. Effective September 1, 2003, Section 1071.051(a), Occupations Code, is amended to read as follows:
- 9 (a) The Texas Board of Professional Land Surveying consists 10 of nine [<del>10</del>] members as follows:
- 11 (1) the commissioner;
- 12 (2) two licensed state land surveyor members actively
  13 engaged in the practice of state land surveying for not less than
  14 the five years preceding appointment;
- 15 (3) three [four] registered professional land
  16 surveyor members actively engaged in the practice of professional
  17 surveying in this state for not less than the five years preceding
  18 appointment; and
- 19 (4) three members who represent the public.

- 7 (1) by statute the governing body is composed of an
- 8 even number of voting members, the appointed members of whom serve
- 9 staggered six-year terms; and
- 10 (2) there is no provision of the Texas Constitution
- 11 under which the governing body is allowed to be composed in that
- manner.
- 13 (b) Notwithstanding the terms of the statute that
- 14 prescribes the composition and terms of the governing body, the
- appointed members of the governing body serve two-year terms.
- 16 (c) The terms of the members of the governing body who have
- 17 served less than two years since the date their current terms began
- 18 expire on the second anniversary of the date their current terms
- 19 began. The members of the governing body who have served two or
- 20 more years since the date their current terms began are considered
- 21 to be performing the duties of their office in a holdover capacity
- 22 until their successors are qualified in accordance with Section 17,
- 23 Article XVI, Texas Constitution.
- 24 (d) As soon as possible after it is determined that this
- 25 section applies to the governing body, the administrative head of
- 26 the state board or commission or other state agency shall inform of
- 27 that fact:

- 1 (1) each state officer or other entity that by statute
- 2 appoints one or more members to the governing body;
- 3 (2) the governor and the presiding officer of each
- 4 house of the legislature;
- 5 (3) each standing committee of each house of the
- 6 legislature that under the rules of either house has jurisdiction
- 7 over legislative matters pertaining to the board, commission, or
- 8 other agency; and
- 9 (4) the Legislative Reference Library for purposes of
- 10 <u>including current information in the Texas Appointment System</u>
- 11 database.
- 12 (e) As soon as possible after an appointing officer or
- entity is informed under Subsection (d), the appointing authority
- 14 shall make any necessary appointments or reappointments to the
- 15 governing body to fill the positions of members described by
- 16 Subsection (c) who are serving in a holdover capacity. If a member
- 17 whose position is being filled has served two or more years but less
- 18 than four years of a term, the appointment made under this
- 19 subsection is for a term expiring on the fourth anniversary of the
- 20 date the term began. If a member whose position is being filled has
- 21 served four or more years but less than six years of a term, the
- 22 appointment made under this subsection is for a term expiring on the
- 23 sixth anniversary of the date the term began.
- 24 SECTION 34.02. If this Act requires that a position is to be
- 25 abolished on September 1, 2003, and in connection with describing
- 26 the position to be abolished incorrectly describes the number of
- 27 positions that are required to be filled by a member with an

- 1 identified qualification for office and that expire on the date
- 2 identified by this Act, then:
- 3 (1) if there is only one position on the governing body
- 4 required to be filled by a member with the identified qualification
- 5 for office with a term scheduled to expire on the identified date,
- 6 that member's term is abolished; and
- 7 (2) if there is more than one position on the governing
- 8 body required to be filled by a member with the identified
- 9 qualification for office with a term scheduled to expire on the
- 10 identified date, all members with the identified qualification for
- office with a term scheduled to expire on the identified date shall
- meet to determine by unanimous agreement or by lot which member's
- 13 position is abolished.
- 14 SECTION 34.03. If a conflict exists between this Act and
- another Act passed by the 78th Legislature, Regular Session, 2003,
- 16 that becomes law, the other law controls unless this Act changes the
- 17 composition of a governing body in a manner allowed by the Texas
- 18 Constitution and the other law changes the composition of the
- 19 governing body in a manner that is not allowed by the Texas
- 20 Constitution.
- 21 SECTION 34.04. Except as otherwise provided by this Act,
- 22 this Act takes effect immediately if it receives a vote of
- 23 two-thirds of all the members elected to each house, as provided by
- 24 Section 39, Article III, Texas Constitution. If this Act does not
- 25 receive the vote necessary for immediate effect, this Act takes
- 26 effect September 1, 2003.
