- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 62.0141, Government Code, is amended to
- 5 read as follows:
- 6 Sec. 62.0141. FAILURE TO ANSWER JURY SUMMONS. In addition
- 7 to any criminal penalty prescribed by law, a person summoned for
- 8 jury service who does not comply with the summons as required by law
- 9 or who knowingly provides false information in a request for an
- 10 <u>exemption or to be excused from jury service</u> is subject to a
- 11 contempt action punishable by a fine of not less than \$100 nor more
- 12 than \$1,000.
- SECTION 2. Subchapter A, Chapter 62, Government Code, is
- amended by adding Sections 62.0142 and 62.022 to read as follows:
- 15 Sec. 62.0142. POSTPONEMENT OF JURY SERVICE. (a) A person
- 16 summoned for jury service may request a postponement of the
- 17 person's initial appearance for jury service. The person may
- 18 request the postponement by contacting the clerk of the court in
- 19 person, in writing, or by telephone before the date on which the
- 20 person is summoned to appear.
- 21 (b) On receipt of a request under Subsection (a), the clerk
- of the court shall grant the person a postponement if:
- 23 (1) the person has not been granted a postponement in
- 24 that county during the one-year period preceding the date on which

- the person is summoned to appear; and
- 2 (2) the person and the clerk determine a substitute
- 3 date on which the person will appear for jury service that is not
- 4 later than six months after the date on which the person was
- 5 originally summoned to appear.
- 6 (c) A person who receives a postponement under Subsection
- 7 (b) may request a subsequent postponement in the manner described
- 8 by Subsection (a). The clerk of the court may approve the
- 9 subsequent postponement only because of an extreme emergency that
- 10 could not have been anticipated, such as a death in the person's
- family, sudden serious illness suffered by the person, or a natural
- 12 disaster or national emergency in which the person is personally
- involved. Before the clerk may grant the subsequent postponement,
- 14 the person and the clerk must determine a substitute date on which
- the person will appear for jury service that is not later than six
- 16 months after the date on which the person was to appear after the
- 17 postponement under Subsection (b).
- 18 Sec. 62.022. LIMITATION ON LENGTH OF SERVICE. A person is
- 19 not required to appear for jury service for more than one day unless
- 20 the person is selected to serve on a particular jury or is being
- 21 <u>considered to serve on a particular jury. Once selected, a juror</u>
- 22 shall serve on the jury until the jury renders a verdict, unless
- 23 excused by the court.
- SECTION 3. The changes in law made by this Act apply only to
- 25 a person summoned to appear for jury service on or after the
- 26 effective date of this Act. A person summoned to appear for jury
- 27 service before the effective date of this Act is governed by the law

- 2 former law is continued in effect for that purpose.
- 3 SECTION 4. This Act takes effect September 1, 2003.
