H.B. No. 3103

A BILL TO BE ENTITLED

1 AN ACT

2 relating to re-codification issues and the deletion of outdated
3 statutes.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 521.146, Transportation Code, is amended
6 to read as follows:

7 Section 521.146. Application for Duplicate License or
8 Certificate (a) If a driver's license or certificate issued under
9 this chapter is lost or destroyed, or there is a change in pertinent
10 information, the person to whom the license or certificate was
11 issued may obtain a duplicate or corrected version.

12 (b) A person who moves from the address shown on the license
13 or certificate or changes the person's name must notify the
14 department of the change and apply for a duplicate license or
15 certificate not later than the 30th day after the date on which the
16 change takes effect.

17 (c) An applicant for a corrected driver's license or
18 certificate must submit to the department the required fee,
19 accompanied by the required information that has changed with proof
20 satisfactory to the department that supports the change.

21 ~~(e)~~ (d) The department by rule may provide that the holder
22 of a driver's license or identification certificate issued by the
23 department may apply for the issuance of a duplicate license or
24 certificate by mail, by telephone, over the Internet, or by other

1 electronic means.

2 ~~(d)~~ (e) A rule adopted under Subsection (c) may prescribe
3 eligibility standards for issuance of a duplicate driver's license
4 or identification certificate under this section.

5 SECTION 2. Section 521.341, Transportation Code, is amended
6 to read as follows:

7 Section 521.341 (2). Requirements For Automatic License
8 Suspension

9 (2) an offense under Section 38.04, Penal Code that
10 was committed while operating a motor vehicle;

11 SECTION 3. Section 601.162 (b)(2), Transportation Code is
12 amended to read as follows:

13 Section 601.162 (b)(2). Duration of Suspension

14 (b)(2) the second anniversary of the date security was
15 ~~deposited~~ required under Subdivision (1) if, during that period, an
16 action on the agreement has not been instituted in a court in this
17 state.

18 SECTION 4. Section 601.340 (a)(1), Transportation Code is
19 amended to read as follows:

20 Section 601.340(a)(1). Evidence of Financial
21 Responsibility or Suspension of Vehicle Registration Following
22 Suspension or Revocation of Driver's License (a) Except as
23 provided by Subsection (b) or (c), the department shall suspend the
24 registration of each motor vehicle registered in the name of a
25 person if the department:

26 (1) under any state law, other than Section 521.341~~(6)~~
27 (7) suspends or revokes the person's driver's license on receipt of

1 a record of a conviction or a forfeiture of bail; or

2 SECTION 5. Sections 521.054, 521.102, 521.423 and
3 522.029(f) as added by Acts of the 75th Legislature, regular
4 session, 1997, chapter 1156, Sec. 2, are repealed.

5 SECTION 6. This Act takes effect on September 01, 2003.
