2	relating to monetary incentives for consolidation of services among

4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 11, Education Code, is
6	amended by adding Section 11.003 to read as follows:
7	Sec. 11.003. GRANTS FOR CONSOLIDATED SERVICES AMONG
8	DISTRICTS. (a) In this section, "service" means an
9	administrative, educational, or other service provided by a school
10	district, including a service related to curriculum design,
11	payroll, purchasing, or technology.
12	(b) The commissioner shall establish a grant program
13	designed to encourage school districts to consolidate services in
14	an effort to improve efficiency and decrease costs related to
15	provision of the services.
16	(c) From funds appropriated or donated for the purpose, the
17	commissioner shall award grants based on criteria adopted by the
18	commissioner.
19	(d) To be eligible to receive a grant, a school district
20	<u>must:</u>
21	(1) apply within the period and in the manner required
22	by the commissioner; and
23	(2) provide the commissioner with evidence of
24	projected increased efficiency and monetary savings that will

1	result from consolidating services with another district.
2	(e) The commissioner shall determine the amount of a grant
3	awarded under this section. In making that determination, the
4	commissioner shall ensure that the grant amount is:
5	(1) based on a percentage of the monetary savings
6	projected to result from the consolidation of services; and
7	(2) sufficient to encourage school districts to
8	consolidate services and apply for grants.
9	(f) The commissioner may seek private contributions to
10	increase the amount of state money available to fund the grant
11	program.
12	(g) Not later than December 1 of each even-numbered year,
13	the commissioner shall submit to the legislature a report on the
14	grant program. The report must include:
15	(1) a description of how the consolidation of services
16	among school districts affects necessary district operations;
17	(2) a statement of applicable efficiencies of scale,
18	expressed in measurable terms;
19	(3) the payment schedule used for grants; and
20	(4) a method for computing and documenting
21	efficiencies resulting from consolidation of services among
22	districts.
23	SECTION 2. Subject to the availability of funding, the
24	commissioner of education shall adopt rules necessary to administer
25	the grant program authorized by Section 11.003, Education Code, as
26	added by this Act, not later than January 1, 2004.
27	SECTION 3. This Act takes effect immediately if it receives

a vote of two-thirds of all the members elected to each house, as
provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2003.
