Section 111.052, Human Resources Code, is amended to read as follows: 6 Sec. 111.052. GENERAL FUNCTIONS. (a) 7 The commission shall, to the extent of resources available and priorities 8 established by the board, provide rehabilitation services directly 9 or through public or private resources to individuals determined by 10 11 the commission to be eligible for the services under a vocational 12 rehabilitation program[, an extended rehabilitation services program,] or other program established to provide rehabilitative 13 14 services. In carrying out the purposes of this chapter, the 15 (b) 16 commission may: (1) cooperate with other departments, agencies, 17 18 political subdivisions, and institutions, both public and private, in providing the services authorized by this chapter to eligible 19 individuals, in studying the problems involved, and in planning, 20 establishing, developing, and providing necessary or desirable 21 programs, facilities, and services, including those jointly 22 23 administered with state agencies; 24 (2) enter into reciprocal agreements with other

2 establish or construct rehabilitation facilities (3) and workshops, contract with or provide grants to agencies, 3 4 organizations, or individuals as necessary to implement this 5 chapter, make contracts or other arrangements with public and other 6 nonprofit agencies, organizations, or institutions for the 7 establishment of workshops and rehabilitation facilities, and 8 operate facilities for carrying out the purposes of this chapter;

9 (4) conduct research and compile statistics relating 10 to the provision of services to or the need for services by disabled 11 individuals;

(5) provide for the establishment, supervision, management, and control of small business enterprises to be operated by individuals with significant disabilities where their operation will be improved through the management and supervision of the commission;

17 (6) contract with schools, hospitals, private
18 industrial firms, and other agencies and with doctors, nurses,
19 technicians, and other persons for training, physical restoration,
20 transportation, and other rehabilitation services; and

(7) assess the statewide need for services necessary to prepare students with disabilities for a successful transition to employment, establish collaborative relationships with each school district with education service centers to the maximum extent possible within available resources, and develop strategies to assist vocational rehabilitation counselors in identifying and reaching students in need of transition planning [contract with a
