4	SECTION 1. Subchapter A, Chapter 101, Occupations Code, is
5	amended by adding Sections 101.008, 101.0081, 101.009, 101.010,
6	101.011, and 101.012 to read as follows:
7	Sec. 101.008. SUNSET PROVISION. The Health Professions
8	Council is subject to Chapter 325, Government Code (Texas Sunset
9	Act). Unless continued in existence as provided by that chapter,
LO	the council is abolished and this chapter expires September 1,
L1	2015.
L2	Sec. 101.0081. SPECIAL PURPOSE SUNSET REVIEW. (a) During
L3	the period preceding the regular session of the 79th Legislature,
L4	the Sunset Advisory Commission shall perform a special purpose
L5	review of the council. In the review, the sunset commission may only
L6	review the appropriateness of the recommendations made by the
L7	commission to the regular session of the 78th Legislature regarding
L8	the council. In the sunset commission's report to the 79th
L9	Legislature, the commission may include any of those prior
20	recommendations the commission considers appropriate.
21	(b) The council and the agencies composing the council shall
22	cooperate with the Sunset Advisory Commission in the review and
23	shall provide to the commission any information the commission

considers necessary for the review.

- 2 Sec. 101.009. RULES. (a) The council may adopt rules to
- 3 govern the operation and administration of an agency listed in
- 4 Section 101.002.
- 5 (b) The council may adopt rules related to the management of
- 6 an agency listed in Section 101.002, including rules governing
- 7 <u>information technology</u>, human resources, and financial services.
- 8 (c) The council may not adopt a rule related to the practice
- 9 of a profession regulated by an agency listed in Section 101.002.
- Sec. 101.010. COUNCIL POLICIES. The council shall adopt
- 11 policies to govern the agencies that compose the council.
- Sec. 101.011. COUNCIL POWERS. (a) The council may manage
- 13 the operations of an agency listed in Section 101.002.
- 14 (b) The council shall exercise the administrative
- 15 responsibilities of information technology, human resources, and
- financial operations of an agency listed in Section 101.002.
- 17 Sec. 101.012. DIVISION OF RESPONSIBILITIES. (a) The
- 18 council shall develop and implement policies that clearly separate
- 19 the policy-making responsibilities and the management
- 20 responsibilities of the council and the agencies that compose the
- 21 <u>council.</u>
- (b) Notwithstanding any other law, an agency listed in
- 23 Section 101.002 may not adopt a rule related to the organization,
- 24 operating procedures, or management of the agency that is
- 25 determined by council rule to be within the council's
- 26 responsibility.
