The 8 compensation shall be paid from the general fund of the county. 9 SECTION 5. Section 54.505, Government Code, is amended to read as follows: 10 Sec. 54.505. JUDICIAL IMMUNITY [FEES]. An associate judge 11 12 has the same judicial immunity as a district judge. [(a) On each tax case referred to a master, the judge shall set the master's fee, 13 14 and that fee shall be added as court costs. 15 [(b) On each case referred to a master other than tax cases, the master shall recommend the fee to be charged, but the fee is 16 subject to the approval of the referring judge.] 17 SECTION 6. 4	effect as an order of the referring court unless a party appeals the

6	(b) To appeal an associate judge's decision, other than the
7	issuance of a temporary restraining order or temporary injunction,
8	a party must file an appeal in the referring court not later than
9	the third day after the date the party receives notice of the
10	decision under Subsection (a).
11	(c) A temporary restraining order issued by an associate
12	judge is effective immediately and expires on the 15th day after the
13	date of issuance unless, after a hearing, the order is modified or
14	extended by the associate judge or a district judge.
15	(d) A temporary injunction issued by an associate judge is
16	effective immediately and continues during the pendency of a trial
17	unless, after a hearing, the order is modified by a district judge.

7	(c) An associate judge may be reimbursed for expenses
8	incurred in complying with the requirements of this section if
9	sufficient funds are available in the budget for continuing
10	judicial education. [A witness who appears before the master and is
11	sworn is subject to the penalties for perjury provided by law.
