Section 1602.254(b), Occupations 4 Code, is 5 amended to read as follows: 6 (b) To be eligible for an operator license, an applicant 7 must: 8 (1) be at least 17 years of age; obtained a high school diploma, the 9 (2) have equivalent of a high school diploma, or have passed a valid 10 examination administered by a certified testing agency that 11 12 measures the person's ability to benefit from training [completed 13 the seventh grade or its equivalent]; and (3) have completed: 14 1,500 hours of instruction in a licensed 15 (A) beauty culture school; or 16 (B) 1,000 hours of instruction in beauty culture 17 courses and 500 hours of related high school courses prescribed by 18 the commission in a vocational cosmetology program in a public 19 20 school. 21 SECTION 2. Section 1602.256(b), Occupations Code, is 22 amended to read as follows: (b) To be eligible for a manicurist license, an applicant 23 24 must:

SECTION 5. Section 1602.261, Occupations Code, is amended 10 to read as follows: 11

Sec. 1602.261. EXAMINATION RESULTS. (a) 12 The commission shall notify each examinee of the results of the examination not 13 later than the 30th day after the date an examination is 14 15 administered. If an examination is graded or reviewed by a national testing service, the commission shall notify each examinee of the 16 17 results of the examination not later than the 14th day after the date the commission receives the results from the testing service. 18

If the notice of examination results graded or reviewed 19 (b) by a national testing service will be delayed for longer than 90 20 days after the examination date, the commission shall notify the 21 examinee of the reason for the delay before the 90th day. 22

[(c) If the examinee is a student in a vocational 23 24 cosmetology program in a public school, the commission shall grade 25 the examination and may not submit the examination for grading by a 26 national testing service.]

(c) [(d)] If requested in writing by a person who fails the

2 the 60th day after the day the request is received by the commission
3 an analysis of the person's performance on the examination.

4 SECTION 6. Section 1602.304, Occupations Code, is amended 5 to read as follows:

6 Sec. 1602.304. PUBLIC SECONDARY OR POSTSECONDARY BEAUTY 7 CULTURE SCHOOL CERTIFICATE. (a) Each application for <u>a license</u> 8 [<del>certification</del>] as a public secondary or public post secondary 9 beauty culture school must be accompanied by the required <u>license</u> 10 [inspection] fee.

(b) The commission shall charge an inspection fee for each inspection trip required before approval of the <u>license</u> [certificate].

SECTION 7. Section 1602.351(c), Occupations Code, is amended to read as follows:

(c) A private beauty culture school license <u>or a public</u>
 <u>secondary or post secondary beauty culture school license</u> expires
 on the anniversary of the date the license is issued.

SECTION 8. Section 1602.354, Occupations Code, is amended to read as follows:

Sec. 1602.354. CONTINUING EDUCATION. The commission <u>will</u> <u>by rule [may]</u> recognize, prepare, or administer continuing education programs for the practice of cosmetology. Participation in the programs is <u>mandatory for all license renewals</u> [<del>voluntary</del>].

25 SECTION 9. This Act takes effect September 1, 2003, except 26 that Section 8 of this Act and the amendment to section 27 1602.257(b)(3) in Section 3 of this Act take effect September 1,
