(j) A provision in a trust created under this section that 11 12 relieves a trustee from a duty, responsibility, or liability imposed by this section or Subtitle B, Title 9, is enforceable only 13 14 if: 15 (1) the provision is limited to specific facts and circumstances unique to the property of that trust and is not 16 17 applicable generally to the trust; and (2) the court creating or modifying the trust makes a 18 19 specific finding that there is clear and convincing evidence that the inclusion of the provision is in the best interests of the 20 21 beneficiary of the trust. SECTION 4.
