A BILL TO BE ENTITLED

1 AN ACT

2 relating to renumbering or relettering certain provisions of  
3 enacted codes.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. This Act is enacted as part of the state's  
6 continuing statutory revision program under Chapter 323,  
7 Government Code. This Act is a revision for purposes of Section 43,  
8 Article III, Texas Constitution.
