1 AN ACT 2 relating to the creation of the Harris County Road Improvement 3 District No. 2; providing authority to impose a tax and issue bonds. (b) The board shall determine the tax rate.

SECTION 17. ASSESSMENTS; PETITION REQUIRED FOR FINANCING
SERVICES AND IMPROVEMENTS. (a) The board by resolution may impose
and collect an assessment for any purpose authorized by this Act.

10 (b) The board may not finance a service or improvement 11 project through an assessment under this Act unless a written 12 petition requesting that service or improvement has been filed with 13 the board. The petition must be signed by:

(1) the owners of a majority of the assessed value of real property in the district that will be subject to the assessment according to the most recent certified tax appraisal roll for the county in which the property is located; or

18 (2) at least 25 owners of land in the district that 19 will be subject to the assessment, if more than 25 persons own land 20 in the district that will be subject to the assessment according to 21 the most recent certified tax appraisal roll for the county in which 22 the property is located.

(c) An assessment, a reassessment, or an assessment resulting from an addition to or correction of the assessment roll by the district, penalties and interest on an assessment or reassessment, an expense of collection, and reasonable attorney's fees incurred by the district:

H.B. No. 3555 1 (1) are a first and prior lien against the property 2 assessed;

3 (2) are superior to any other lien or claim other than 4 a lien or claim for county, school district, or municipal ad valorem 5 taxes; and

6 (3) are the personal liability of and charge against 7 the owners of the property even if the owners are not named in the 8 assessment proceeding.

9 (d) The lien is effective from the date of the board's 10 resolution imposing the assessment until the date the assessment is 11 paid. The board may enforce the lien in the same manner that the 12 board may enforce an ad valorem tax lien against real property.

13 SECTION 18. OBLIGATIONS. (a) The district may issue bonds 14 or other obligations payable in whole or in part from ad valorem 15 taxes, assessments, impact fees, revenue, grants, or other money of 16 the district, or any combination of those sources of money, to pay 17 for any authorized purpose of the district.

(b) In exercising the district's borrowing power, the district may issue a bond or other obligation in the form of a bond, note, certificate of participation or other instrument evidencing a proportionate interest in payments to be made by the district, or other type of obligation.

3 (b) Of the initial directors, the terms of the first three 4 directors named in Subsection (a) expire on June 1, 2006, and the 5 terms of the last two directors named in Subsection (a) expire on 6 June 1, 2004.

7 (c) On the uniform election date in May 2004, the board 8 shall hold an election for the directors whose terms expire on June 9 1, 2004. On the uniform election date in May 2006, the board shall 10 hold an election for the directors whose terms expire on June 1, 11 2006.

(d) This section expires September 1, 2006.

13 SECTION 20. ADDITIONAL LEGISLATIVE FINDINGS. The 14 legislature finds that:

15 (1) proper and legal notice of the intention to introduce this Act, setting forth the general substance of this 16 Act, has been published as provided by law, and the notice and a 17 copy of this Act have been furnished to all persons, agencies, 18 officials, or entities to which they are required to be furnished by 19 the constitution and laws of this state, including the governor, 20 who has submitted the notice and Act to the Texas Commission on 21 Environmental Quality; 22

(2) the Texas Commission on Environmental Quality has
filed its recommendations relating to this Act with the governor,
lieutenant governor, and speaker of the house of representatives
within the required time;

(3) the general law relating to consent by political

1 subdivisions to the creation of districts with conservation,
2 reclamation, and road powers and the inclusion of land in those
3 districts has been complied with; and

4 (4) all requirements of the constitution and laws of 5 this state and the rules and procedures of the legislature with 6 respect to the notice, introduction, and passage of this Act have 7 been fulfilled and accomplished.

8 SECTION 21. EFFECTIVE DATE. This Act takes effect 9 immediately if it receives a vote of two-thirds of all the members 10 elected to each house, as provided by Section 39, Article III, Texas 11 Constitution. If this Act does not receive the vote necessary for 12 immediate effect, this Act takes effect September 1, 2003.
