A BILL TO BE ENTITLED

AN ACT

2 relating to the creation of the Harris County Road Improvement 3 District No. 2; providing authority to impose a tax and issue bonds. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. CREATION OF DISTRICT. (a) Harris County Road 6 Improvement District No. 2 is created as a special district under 7 Section 52, Article III, and Section 59, Article XVI, Texas 8 Constitution.

(b) The board by resolution may change the district's name.

10 SECTION 2. DECLARATION OF INTENT. (a) The creation of the 11 district is necessary to promote, develop, encourage, and maintain 12 transportation, safety, employment, commerce, housing, tourism, 13 recreation, the arts, entertainment, economic development, and the 14 public welfare in the area of the district.

(b) The creation of the district is essential to accomplish the purposes of Sections 52 and 52-a, Article III, and Section 59, Article XVI, Texas Constitution, and other public purposes stated in this Act.

SECTION 3. DEFINITIONS. In this Act:

20 (1) "Board" means the board of directors of the 21 district.

(2) "District" means Harris County Road ImprovementDistrict No. 2.

7 (1) the owners of a majority of the assessed value of
8 real property in the district that will be subject to the assessment
9 according to the most recent certified tax appraisal roll for the
10 county in which the property is located; or

(2) at least 25 owners of land in the district that will be subject to the assessment, if more than 25 persons own land in the district that will be subject to the assessment according to the most recent certified tax appraisal roll for the county in which the property is located.

16 (c) An assessment, a reassessment, or an assessment 17 resulting from an addition to or correction of the assessment roll 18 by the district, penalties and interest on an assessment or 19 reassessment, an expense of collection, and reasonable attorney's 20 fees incurred by the district:

21 (1) are a first and prior lien against the property 22 assessed;

(2) are superior to any other lien or claim other than
a lien or claim for county, school district, or municipal ad valorem
taxes; and

(3) are the personal liability of and charge againstthe owners of the property even if the owners are not named in the

1 assessment proceeding.

2 (d) The lien is effective from the date of the board's 3 resolution imposing the assessment until the date the assessment is 4 paid. The board may enforce the lien in the same manner that the 5 board may enforce an ad valorem tax lien against real property.

6 SECTION 18. OBLIGATIONS. (a) The district may issue bonds 7 or other obligations payable in whole or in part from ad valorem 8 taxes, assessments, impact fees, revenue, grants, or other money of 9 the district, or any combination of those sources of money, to pay 10 for any authorized purpose of the district.

(b) In exercising the district's borrowing power, the district may issue a bond or other obligation in the form of a bond, note, certificate of participation or other instrument evidencing a proportionate interest in payments to be made by the district, or other type of obligation.

SECTION 19. INITIAL DIRECTORS. (a) The initial board consists of the following persons:

(b) Of the initial directors, the terms of the first three directors named in Subsection (a) expire on June 1, 2006, and the terms of the last two directors named in Subsection (a) expire on June 1, 2004.

1 (c) On the uniform election date in May 2004, the board 2 shall hold an election for the directors whose terms expire on June 3 1, 2004. On the uniform election date in May 2006, the board shall 4 hold an election for the directors whose terms expire on June 1, 5 2006.

(d) This section expires September 1, 2006.

7 SECTION 20. ADDITIONAL LEGISLATIVE FINDINGS. The8 legislature finds that:

9 proper and legal notice of the intention to (1)introduce this Act, setting forth the general substance of this 10 Act, has been published as provided by law, and the notice and a 11 copy of this Act have been furnished to all persons, agencies, 12 officials, or entities to which they are required to be furnished by 13 14 the constitution and laws of this state, including the governor, 15 who has submitted the notice and Act to the Texas Commission on Environmental Quality; 16

17 (2) the Texas Commission on Environmental Quality has
18 filed its recommendations relating to this Act with the governor,
19 lieutenant governor, and speaker of the house of representatives
20 within the required time;

(3) the general law relating to consent by political subdivisions to the creation of districts with conservation, reclamation, and road powers and the inclusion of land in those districts has been complied with; and

(4) all requirements of the constitution and laws of
this state and the rules and procedures of the legislature with
respect to the notice, introduction, and passage of this Act have

1 been fulfilled and accomplished.

2 SECTION 21. EFFECTIVE DATE. This Act takes effect 3 immediately if it receives a vote of two-thirds of all the members 4 elected to each house, as provided by Section 39, Article III, Texas 5 Constitution. If this Act does not receive the vote necessary for 6 immediate effect, this Act takes effect September 1, 2003.
