- 1 AN ACT
- 2 relating to the creation, administration, powers, duties,
- 3 operation, and financing of the Lazy Nine Municipal Utility
- 4 District.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. DEFINITIONS. In this Act:
- 7 (1) "Board" means the board of directors of the
- 8 district.
- 9 (2) "District" means the Lazy Nine Municipal Utility
- 10 District.
- 11 SECTION 2. CREATION. (a) A municipal utility district, to
- 12 be known as the Lazy Nine Municipal Utility District, is created in
- 13 Travis County, subject to approval at a confirmation election under
- 14 Section 9 of this Act.
- 15 (b) The district is a governmental agency and a political
- 16 subdivision of this state.
- 17 SECTION 3. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a) The
- 18 district is created to serve a public use and benefit.
- 19 (b) The district is created under and is essential to
- 20 accomplish the purposes of Section 59, Article XVI, Texas
- 21 Constitution.
- (c) All of the land and other property included within the
- 23 boundaries of the district will be benefited by the works and
- 24 projects that are to be accomplished by the district under powers

- 1 conferred by Section 59, Article XVI, Texas Constitution.
- 2 SECTION 4. BOUNDARIES. The boundaries of the district are
- 3 as follows:

- 26 district form a closure. If a mistake is made in the field notes or
- 27 in copying the field notes in the legislative process, the mistake

- does not affect in any way:
- 2 (1) the organization, existence, or validity of the
- 3 district;
- 4 (2) the right of the district to impose taxes; or
- 5 (3) the legality or operation of the district or the
- 6 board.
- 7 SECTION 6. APPLICABILITY OF OTHER LAW. This Act prevails
- 8 over any provision of general law that is in conflict or
- 9 inconsistent with this Act.
- 10 SECTION 7. BOARD OF DIRECTORS. (a) The district is
- 11 governed by a board of five directors.
- 12 (b) Temporary directors serve until directors are elected
- 13 under Section 9 of this Act.
- 14 (c) Temporary directors of the district, or of a new
- 15 district created by division of the district under Section 13 of
- 16 this Act, are not required to own land in or be residents of the
- 17 district.
- 18 (d) Permanent directors serve staggered four-year terms.
- 19 (e) Each director must qualify to serve as director in the
- 20 manner provided by Section 49.055, Water Code.
- 21 SECTION 8. TEMPORARY DIRECTORS. (a) The temporary board
- 22 consists of:
- 23 (1) C.A. Elder;
- 24 (2) Gary Valdez;
- 25 (3) Vincent Huebinger;
- 26 (4) Bill Simpson; and
- 27 (5) Cord Shifflett.

- 1 (b) If a temporary director fails to qualify for office, the
- 2 temporary directors who have qualified shall appoint a person to
- 3 fill the vacancy. If at any time there are fewer than three
- 4 qualified temporary directors, the Texas Commission on
- 5 Environmental Quality shall appoint the necessary number of persons
- 6 to fill all vacancies on the board.
- 7 SECTION 9. CONFIRMATION AND INITIAL DIRECTORS' ELECTION.
- 8 (a) The temporary board shall call and hold an election to confirm
- 9 establishment of the district and to elect initial directors under
- 10 Section 49.102, Water Code.
- 11 (b) At the confirmation and initial directors' election the
- 12 board may submit to the voters a proposition to authorize:
- 13 (1) an issuance of bonds;
- 14 (2) a maintenance tax; or
- 15 (3) a tax to fund payments required under a contract.
- 16 (c) Section 41.001(a), Election Code, does not apply to a
- 17 confirmation and initial directors' election held as provided by
- 18 this section.
- 19 SECTION 10. ELECTION OF DIRECTORS. (a) On the first
- 20 Saturday in May of the first even-numbered year after the year in
- 21 which the district is authorized to be created at a confirmation
- 22 election, an election shall be held in the district for the election
- 23 of two directors to replace the two initial directors serving
- 24 shorter terms from the confirmation election.
- 25 (b) On the first Saturday in May of each subsequent
- 26 even-numbered year following the election, the appropriate number
- 27 of directors shall be elected.

- 1 SECTION 11. GENERAL POWERS. The district has all of the
- 2 rights, powers, privileges, authority, functions, and duties
- 3 provided by the general law of this state, including Chapters 30,
- 4 49, 50, and 54, Water Code, applicable to municipal utility
- 5 districts created under Section 59, Article XVI, Texas
- 6 Constitution.
- 7 SECTION 12. ANNEXATION. The board may annex land as
- 8 provided by Chapter 49 or Chapter 54, Water Code.
- 9 SECTION 13. DIVISION OF DISTRICT. (a) Notwithstanding any
- 10 other law, either before or after annexing land into the district
- 11 under Section 12 of this Act, and before issuing indebtedness
- secured by taxes or net revenues, the board may divide the territory
- 13 of the district, including any annexed territory, into two or more
- 14 new districts.
- 15 (b) A new district created by division of the district must
- 16 be at least 100 acres in size.
- 17 SECTION 14. ELECTION FOR DIVISION OF DISTRICT. (a) On a
- 18 board resolution consenting to the terms and conditions of a
- 19 division under Section 13 of this Act, including a plan for payment
- 20 and performance of any outstanding obligations of the district, and
- 21 a metes and bounds description of the proposed new districts, the
- 22 board shall order an election to be held in the district to
- 23 determine if the district should be divided as proposed.
- (b) The board shall give notice of the election not later
- 25 than the 20th day before the election in the manner provided by
- 26 Section 49.102, Water Code.
- (c) Not later than the 30th day after the date of the

- 1 election the district shall provide written notice of the plan for
- 2 division to:
- 3 (1) the Texas Commission on Environmental Quality;
- 4 (2) the attorney general;
- 5 (3) the commissioners court of each county in which
- 6 each new district is located; and
- 7 (4) any municipality having extraterritorial
- 8 jurisdiction over the land within each new district.
- 9 SECTION 15. GOVERNANCE OF DISTRICTS AFTER DIVISION. (a) On
- 10 a vote of a majority of the qualified electors in the district in
- 11 favor of dividing the district in an election held under Section 14
- 12 of this Act, the district shall be divided.
- 13 (b) The resulting new districts shall be assigned
- 14 consecutive letters, corresponding to the number of the new
- 15 district.
- 16 (c) The resulting new districts shall be separate districts
- 17 and shall be governed as separate districts.
- 18 (d) Until the 91st day after the date of the election
- 19 approving the division of the district, the board shall continue to
- 20 act on behalf of the district to wind up the affairs of the
- 21 district.
- 22 SECTION 16. ELECTION OF DIRECTORS OF NEW DISTRICT. (a)
- 23 After an election approving the division of the district, the
- 24 directors of the board shall:
- 25 (1) continue to act as directors of one of the new
- 26 districts; and
- 27 (2) appoint temporary directors for each of the other

- new districts not later than the 90th day after the date of the election approving the division of the district.
- 3 (b) Temporary directors appointed under Subsection (a) of 4 this section shall serve until an election for permanent directors 5 is held on the next uniform election date under Section 41.001(a), 6 Election Code. The temporary directors of each new district must 7 qualify under Section 49.055, Water Code, not later than the 90th 8 day after the date of the election approving the district. The 9 temporary directors shall take office at the expiration of this
- 11 (c) On election of directors under Subsection (b) of this 12 section, the three directors receiving the greatest number of votes 13 shall serve until May of the first even-numbered year that is four 14 years after the date of the election and two directors shall serve 15 until May of the first even-numbered year that is two years after 16 the date of the election.

- 17 (d) The board of each new district shall approve the bond of each of its directors.
- SECTION 17. CONTINUING POWERS AND OBLIGATIONS OF NEW DISTRICTS. (a) Each new district shall have the power to incur and pay debts and shall in every respect have the full power and authority of the district created and governed by this Act.
- (b) If the district is divided in an election under Section 14 of this Act, the current obligations and any bond authorizations of the district are not impaired. The debts shall be paid by taxes, revenues, or assessments levied on the land in the district as if the district had not been divided or by contributions from each new

- district on terms stated and agreed to in the division plan proposed
- 2 by the board and approved by an election under Section 14 of this
- 3 Act.
- 4 (c) Any other obligation of the district shall be divided
- 5 pro rata among the new districts on an acreage basis or on other
- 6 terms that are satisfactory to the new districts.
- 7 SECTION 18. CONTRACT AUTHORITY OF NEW DISTRICTS. The new
- 8 districts may contract with each other for water, wastewater, and
- 9 any other matters the board of each new district considers
- 10 appropriate.
- 11 SECTION 19. BOND ISSUANCE BY NEW DISTRICT. (a) A new
- 12 district that is created as a result of an election approving the
- 13 division of the district as provided by Section 14 of this Act may
- issue bonds payable wholly or partially from ad valorem taxes on the
- approval of a majority of the residents voting in an election called
- 16 and held for that purpose.
- 17 (b) Notice of the bond election shall be given as provided
- 18 by Section 49.106, Water Code.
- 19 SECTION 20. MAINTENANCE TAX APPROVAL FOR NEW DISTRICT. A
- 20 new district that is created as a result of an election approving
- 21 the division of the district as provided by Section 14 of this Act
- 22 may levy a maintenance tax on the approval of a majority of the
- 23 residents voting in an election called and held for that purpose.
- 24 SECTION 21. FINDINGS RELATED TO PROCEDURAL REQUIREMENTS.
- 25 (a) The legal notice of the intention to introduce this Act,
- 26 setting forth the general substance of this Act, has been published
- 27 as provided by law, and the notice and a copy of this Act have been

- 1 furnished to all persons, agencies, officials, or entities to which
- 2 they are required to be furnished under Section 59, Article XVI,
- 3 Texas Constitution, and Chapter 313, Government Code. The
- 4 governor, one of the required recipients, has submitted the notice
- 5 and Act to the Texas Commission on Environmental Quality.
- 6 (b) The Texas Commission on Environmental Quality has filed
- 7 its recommendations relating to this Act with the governor,
- 8 lieutenant governor, and speaker of the house of representatives
- 9 within the required time.
- 10 (c) All requirements of the constitution and laws of this
- 11 state and the rules and procedures of the legislature with respect
- 12 to the notice, introduction, and passage of this Act are fulfilled
- 13 and accomplished.
- 14 SECTION 22. EFFECTIVE DATE; EXPIRATION DATE. (a) This Act
- takes effect September 1, 2003.
- 16 (b) If the creation of the district is not confirmed at a
- 17 confirmation election held under Section 9 of this Act before
- 18 September 1, 2005, this Act expires on that date.
