A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the creation, administration, powers, duties,
- 3 functions, operations, and financing of the Johnson County Special
- 4 Utility District.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. CREATION. (a) A conservation and reclamation
- 7 district is created in Johnson, Hill, Ellis, and Tarrant counties
- 8 to be known as the Johnson County Special Utility District. The
- 9 district is a governmental agency and a body politic and corporate.
- 10 (b) The district is created under and is essential to
- 11 accomplish the purposes of Section 59, Article XVI, Texas
- 12 Constitution.
- 13 SECTION 2. DEFINITION. In this Act, "district" means the

Notice and a copy of an application for expansion of powers shall be provided to each municipality whose 10 jurisdiction, including extraterritorial jurisdiction, overlaps 11 the district's boundaries, in addition to complying with any other 12 applicable notice requirements. If a municipality that is entitled 13 14 to the notice required by this section timely files a request for a 15 contested case hearing within 60 days after receipt of the notice, the Texas Commission on Environmental Quality shall directly refer 16 17 the application to the State Office of Administrative Hearings for a contested case hearing. 18
- 19 (d) This Act prevails over any provision of general law that 20 is in conflict with or inconsistent with this Act.
- 21 (e) The rights, powers, privileges, authority, functions, 22 and duties of the district are subject to the continuing right of 23 supervision of the state to be exercised by and through the Texas 24 Commission on Environmental Quality.
- 25 SECTION 7. REGULATORY CONFLICTS. If a municipality asserts 26 regulatory authority, including water quality standards, over any 27 geographic area lying within the jurisdiction of the district, the
