HOUSE CONCURRENT RESOLUTION

1 WHEREAS, Many proud citizens of Liberty County are visiting 2 the State Capitol on February 24, 2003, to celebrate their county's 3 important role in the annals of the Lone Star State; and

WHEREAS, Embracing a section of the Big Thicket to the north and coastal prairies and marshes to the south, Liberty County presents a strikingly varied landscape; artifacts uncovered near the towns of Liberty and Dayton indicate that people have supported themselves in this fertile land for at least 3,000 years; and

WHEREAS, Karankawa Indians, the first occupants of the area 9 in historic times, were joined around 1807 by Coushatta Indians 10 11 from Alabama; others moving into the district from the mid-1700s 12 onward included Spaniards, who by 1757 had built a military road through the area, French supporters of Napoleon Bonaparte, who 13 14 established a colony there in 1818, and Americans, who became increasingly interested in Texas after the purchase of 15 the 16 Louisiana Territory; and

WHEREAS, In 1831 Mexican authorities established the town of 17 18 Liberty as the seat of a new municipality, which embraced most of Southeast Texas; with the advent of the Republic of Texas in 1836, 19 Liberty County became one of 23 new counties created by the Texas 20 21 Congress, and the town of Liberty continued as the seat of local government; as originally drawn, the boundaries of Liberty County 22 23 included present-day Tyler County and parts of Hardin, Chambers, 24 San Jacinto, and Polk counties; and

WHEREAS, Standing at the highest navigable point on the 1 2 Trinity River, the county seat quickly enjoyed prominence as a 3 commercial center; among those who practiced law in the young town 4 were David G. Burnet, William B. Travis, and Sam Houston, the latter 5 of whom maintained a law office in Liberty and handled cases there 6 from 1838 to 1855; the hero of San Jacinto also acquired some 20,000 7 acres in the county and established two plantation homes on his 8 property; and

9 WHEREAS, Other prominent Texans associated with Liberty 10 County include Governors Ross S. Sterling, who lived there for a 11 time, and Marion Price Daniel, Sr., who was born in Dayton and made 12 his home in Liberty with his wife, Jean, a direct descendant of Sam 13 Houston; and

14 WHEREAS, With approximately half of its area constituting 15 prime farmland, Liberty County has long counted farming and 16 ranching as pillars of its economy; adding to its prosperity are an 17 industrial sector that includes lumbering, oil production, 18 chemical plants, and varied manufacturing; and

WHEREAS, Noted attractions in the county include the Big Thicket National Preserve and, in the town of Liberty, the Sam Houston Regional Library and Research Center and the Humphreys Cultural Center; the county seat also boasts the Trinity Valley Exposition, an annual fair that has been drawing enthusiastic participants and visitors for nearly a century; and

25 WHEREAS, The citizens of Liberty County, today more than 26 70,000 strong, are preserving the best of their past while 27 continuing to forge an ever brighter future for themselves and
