HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The passing of Dr. Marion Jack Brooks of Fort Worth 2 on March 3, 2003, at the age of 83, has brought a great loss to the 3 family, friends, and fellow citizens of this esteemed gentleman, 4 and it is indeed appropriate to recognize his life and many 5 accomplishments at this time; and

6 WHEREAS, A native of Fort Worth, Dr. Brooks was born to Roy 7 and Eula Brooks on February 15, 1920; he was a graduate of I. M. 8 Terrell High School and Prairie View A&M University and earned his 9 medical degree from Howard University in 1951 before he returned to 10 his hometown, becoming one of Fort Worth's first African-American 11 physicians; and

12 WHEREAS, Dr. Brooks and his wife of 57 years, Marie Norris 13 Brooks, were united in marriage on Christmas Day in 1945, and their 14 long and loving union was blessed with 5 children, 10 15 grandchildren, and 3 great-grandchildren; and

16 WHEREAS, A man of ambition, vision, and compassion, Dr. 17 Brooks was a noted leader in the civil rights movement who worked 18 tirelessly to integrate Fort Worth's hospitals for patients as well 19 as doctors; his efforts resulted in greater opportunities for 20 African-American physicians and increased health care options for 21 black patients in Fort Worth; and

22 WHEREAS, Dr. Brooks achieved many firsts during his rich and 23 rewarding life; in 1958, he and his brother, Donald Brooks, joined 24 together to open a medical clinic; in 1961, he became the first

African American to be named to the city's park board; and in 1962,
 he and his wife helped to create Morningside United Methodist

WHEREAS, In his role as an activist, Dr. Brooks founded the Tarrant County Precinct Council and the Sickle Cell Anemia Association of Texas, two organizations that sought to give a voice to underrepresented groups; he overcame adversity throughout his life and encouraged his children to embrace the opportunities available to them and to follow their dreams; and

10 WHEREAS, Dr. Brooks was honored in 1994 with the first Dr. 11 Marion Brooks Annual Living Legend Award presented by the 12 Renaissance Cultural Center; his receipt of this eponymous award 13 was indeed deserved, as Dr. Brooks devoted his life to pursuing 14 equality in the fields of health care, education, and voting 15 rights; and

16 WHEREAS, Though he will be missed by all who knew and loved 17 him, Dr. Marion Jack Brooks has left a legacy for family and friends 18 to embrace and continue to support, and his memory will remain for 19 many years to come in the thoughts, words, and deeds of those 20 individuals who shared his life; now, therefore, be it

21 RESOLVED, That the 78th Legislature of the State of Texas 22 hereby pay tribute to the life of Dr. Marion Jack Brooks and extend 23 sincere sympathy to the members of his family: to his wife, Marie 24 Norris Brooks; to his children, Roy C. Brooks, Clarence Brooks, 25 Carol E. Brooks, Marian Brooks Bryant, and Marie Brooks Washington; 26 to his brother, Donald Brooks; to his 10 grandchildren and 3 27 great-grandchildren; and to the many other individuals who were
