

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, House Bill No. 2292 has been adopted by the house of
2 representatives and the senate and is being prepared for
3 enrollment; and

4 WHEREAS, The bill contains technical errors that should be
5 corrected; now, therefore, be it

6 RESOLVED, by the 78th Legislature of the State of Texas, That
7 the enrolling clerk of the house of representatives be instructed
8 to correct House Bill No. 2292 as follows:

9 (1) Strike SECTION 1.17 of the bill and substitute the
10 following:

11 SECTION 1.17. INITIAL COUNCIL AND COMMITTEE MEETINGS. The
12 presiding officers of the councils for each state agency created
13 under this article, the Family and Protective Services Council and
14 the Health and Human Services Council, and the presiding officer of
15 the Health and Human Services Transition Legislative Oversight
16 Committee shall call the initial meeting of the applicable council
17 or committee as soon as possible after the council or committee
18 members are appointed.

19 (2) In SECTION 1.18(f) of the bill, strike "Subsection
20 (a)(2)(D)" and substitute "Subsection (a)(2)(E)".

21 (3) In SECTION 1.25(b)(1)(A) of the bill, strike "Health and
22 Human Services Transition Legislative Oversight Council" and
23 substitute "Health and Human Services Transition Legislative
24 Oversight Committee".

1 (4) Strike Section 62.102(a), Health and Safety Code, as
2 amended by SECTION 2.48 of the bill, and substitute the following:

3 (a) The commission shall provide that an individual who is
4 determined to be eligible for coverage under the child health plan
5 remains eligible for those benefits until the earlier of:

6 (1) the end of a period, not to exceed 12 months,
7 following the date of the eligibility determination; or

8 (2) the individual's 19th birthday.

9 (5) In Section 533.0355(b)(3), Health and Safety Code, as
10 added by SECTION 2.76 of the bill, strike "Subsection (c)(4)" and
11 substitute "Subsection (c)(3)".

12 (6) In SECTION 2.192(b) of the bill, strike "serving on the
13 council" and substitute "serving on the statewide health
14 coordinating council".

15 (7) In Section 142.0062(a), Health and Safety Code, as
16 amended by SECTION 2.195 of the bill, strike Subdivision (3) and
17 substitute the following:

18 (3) tuberculin purified protein derivative for
19 tuberculosis testing; and

20 (8) In Section 250.001(3)(J), Health and Safety Code, as
21 amended by SECTION 2.198 of the bill, strike "(J)" and substitute
22 "(I)".
